President's Corner

What do SSB County Hunters really want?

I have been putting this column off for quite a while, but after reading the stuff on K3IMC web site and having had so many Email messages and phone calls I think it is time I tell where I stand and why.

The first thing I want everyone to know is that I think Jim, KZ2P is by far the best damn Net Control station I have ever heard on any net. Bar None! On a personal basis I like Jim and find him to be one of the most honest and up-front people I have ever had the pleasure of associating with.

BUT! I totally disagree with his policy of not allowing <u>EVERYONE</u> to run equally on the net.

This is not news to Jim or to anyone that really knows me. Jim and I had a conversation at our first meeting after I came home from Idaho. At that meeting Roger and Jim confronted me saying they heard that "I was going to straighten Jim out!" – We sat and talked at length about it. I agreed that if someone gets drunk and argumentative on the air, that person should be shunned. And if someone persisted in personal attacks, he has to pay the consequences of his actions. There is only one person that I would not "help" on the net (because of his actions on the air) but, when he is mobile, I have run him.

I hate to keep saying this but MARAC does not run the Independent County Hunters Net on 14.336 MHz. I know this more than most because I am one of the three founders on the ICHN on 336 as a breakaway from the CHC/FHC service net in 1967. This net is not run by any club or organization and I have fought long and hard to keep any net rules or anything from becoming formal. The name of the net is Independent County Hunters Net, not the Mobile and Emergency and or whatever you wish to call it. It is the ICHN and the next character is a period. I hear some people saying that I hide behind this statement, and to set the record straight. It is not hiding behind the apron strings of MARAC, but just an honest statement. It is not MARAC's or anyone's net.

Jim and I talked about his association between MARAC and the ICHN and that Jim because he

is an officer of MARAC should set an example for all to follow (wave the flag and slice the apple pie at this point). Jim told me point blank "Bill, You can fire me as treasurer of MARAC tonight but I will be on 14.336 tomorrow morning running the net EXACTLY as I ran it today". Once that statement was made it told me that we were right in our statement about the association between MARAC and the net. He is acting on his own initiative when he runs the net. He is acting as an officer of MARAC at the meetings once a month and as he does MARAC business. He is not acting as an officer of the club when he is on the air any more than he is when he washes his car or mows the lawn. (OK, watches Pat wash the cars, mow the lawn).

If you hear someone out there mobile and he is on Jim's "Bad guy/gal" list just say, "Move a Mobile". Jim will gladly let you move them off the net, he may not announce the move – but he will not stop YOU from moving them. I know this because I have done it (Ask Carol, or ask N4CD when they were refused to run on 14.336). SO what. I moved them: I worked them. So did a bunch of others. You can do the same.

If you think you can do a better job as NCS than Jim don't let anything stop you. If you think you can do a better job as Treasurer of MARAC than Jim, then run for the job and show the world how to represent the club.

If you think you can do a better job as President of MARAC then throw your hat in the ring this job is up for grabs this year, just as are the Secretary and VP slots.

While we are at it, the Great Lakes and Mid Western Division Director jobs are also up for the taking this year. If you want to be part of this dynamic leadership team, enjoy the great pay and vacation opportunities, by all means jump into the pool.

A lot of MARAC members are unhappy with me, and my inability to force Jim into doing something he doesn't want to do. I have talked to Jim and he knows I am not happy with his decision to ban people from the net. This is not a secret, but I have never attacked him as a person. Like I said at the beginning of this column, he is the best damn NCS that we ever had and the net is a much richer place because of him. I wish there was a magic pill that would change his attitude, and everyone would go skipping off hand in hand, but this is real life, there isn't. If you are truly unhappy with the net then go on the CW net. (I understand they are getting more popular and now people are stepping on each other trying to be first to work the mobile and gasp, some of the old timers are feeling stepped on. My heavens! This happens when you have more than 7 people on a frequency). If you are really unhappy then take a hiatus (as I have done) to six meters, PSK, RTTY, satellites or whatever. It's a big hobby, and if you only know this insignificant part of it, then roll over and pull the dirt down on you. The game is up.

County hunters (with all of our petty squabbling) are still the best damn people in the world. Whenever you get a big gathering as we have there is bound to be unhappiness between some. It is a shame that it has come to banishment from the island (I got to watch less TV) but like I said before, it's up to you to either accept the banishment or to stand up and be counted. MOVE A MOBILE. SURE I WILL HAPPILY TAKE THE LIST, should be words that come out of your mouth if you're unhappy.

Don't be afraid that Jim will banish you from the net because you and he don't see eye to eye (I am a good example of this) but don't attack him personally (or anyone to that matter). Attack his methods, his means and you have nothing to fear. There are those on the net that I don't particularly agree with and their operating style. This is a great gang of people, and many are upset by what they conceive as the ruination of county hunting. But again, it's a vast community. There is hope, and I have even heard JIM use PHONETICS twice this afternoon. Maybe he is becoming a bit mellow?

An Open Letter

This is an open letter to all of who love ham radio and county hunting in particular.

First, let me say that I have never had more fun in ham radio than I have had since I've been county hunting. Don't you just love getting a county contact or giving a county contact to someone else? Don't you just love how so many county hunters have helped others in this hobby and in life?

I truly believe that we should also forgive those who do not ask for it or even deserve it. Remember you might be totally right and legal, but if it isn't profitable to our favorite hobby, practice "forgetfulness".

Fourth, whether you agree or disagree with what is stated above, I still plan on hunting counties and giving out counties. If I have offended you in some way by my words or actions, I ask for your "forgiveness" at this time. If you have harmed me in some way, I promise to practice "forgetfulness".

Fifth, please don't bring up these points to me on the air or via e-mail. If you agree with me, practice "forgiveness" and "forgetfulness". If you disagree with me, thanks for listening to my point of view.

Winter County Hunting, by N4CD

December arrived, and N4CD hadn't put out any counties in over a month, so it was time to take a run out toward West Texas. The temperatures had been in the 70s. And I had forgotten all about the last winter trip with WB5P and son in January that wasn't all that much fun when the weather turned bad early.

Several county hunters needed last counties, some that I seem to have driven around many times, and now it was time to 'clean up' those missing ones. It was good to get back to county hunting, where you know the names of most of the ops, and there aren't pileups with people trying desperately anyway they can to work you! Nearly everyone on the net has a cheerful voice. And you have help with the weak ones right at the noise with relays. No relays on DXing!

There are a lot of differences between 'DXing" and county hunting. Besides not using phonetics, the pile-ups are more manageable, we have net controls to help move QRM, and there is some order to what goes on. Well, most of the time.

It was off late on Saturday morning, taking few of a few chores. The net was already running with a couple of mobiles before I got through the traffic mess in the Dallas Fort Worth Metroplex. Gosh, I'd been off on two big DX trips since the last weeklong road trip, and this was just going to be a weekender. Too many things still had to be done. It wasn't January. and it wasn't supposed to snow or sleet. Last January, the N2TPH mobile went on a half day trip to OK that got us caught in ice and snow and worse, just 100 miles from home. This was 400-500 miles out and 400-500 miles back. I didn't even have a route planned, other than hit Comanche and McCulloch, TX. Jim, KZ2P, was doing the NCS job on Saturday.

Once you get past Fort Worth, you can start to zip along. I detoured off I20, which seems to be well run, after running Erath/Stephens county line, and headed south down through Mills, headed toward Comanche, one of the counties my car always seemed to avoid. WD3P needed that on CW. Most of you have seldom heard WD3P on SSB – he chases CW counties, using mill watts, the fewer the better. He snagged me as DX in the Caribbean with only 100 mill watts. I know my receiver/mobile setup is working if I can pull him without too much trouble. I added in two more counties for just another 10-mile detour, and ran them.

The weather was supposed to get 'rainy' in Dallas. Saturday was fine, overcast, and a good day for county hunting. Lots of contacts were made as I zipped through Brown, San Saba, over to McCulloch, Coleman, Concho, Tom Green and some of the other less frequently run

ones. I thought I would spend the night in Sterling County. There is great breakfast place there (world's largest pancakes!). Alas, there is NO motel in Sterling, so I had to drive another 50 miles to Howard county, way after sunset and when I normally stop for the day. Some county hunters run late. I stop when the sun goes down. Too many hazards after dark for me. However, that had a plus side since I met KC1NA in Howard Co for dinner, and he was heading across I20 headed toward the east coast in a big hurry!

Bob was going to drive through Dallas that night and get into Arkansas by morning. I woke up, and the fog was thick, visibility was 100-200 feet, and the temp was 40 deg and dropping I headed north toward Borden and Scurry, always two that the folks need. I took a few wrong turns and almost couldn't find the county line sign visibility was so poor. KC1NA was only 300 miles to the east, and he must have hit some bad weather, too, ran two county lines quick, having to move off frequency since net was busy. Eldon N8STF was out running the U.P. of Michigan. He seemed to get to his county line about 1 minute before I did. Otherwise, Percy was pleading for a #1 mobile to run, and going over numbers with his assistant, killing time. Then, I ran the others along the I20, in pairs, headed east. Over 1000 contacts in the log. Then the rain static started, and I couldn't hear much of anything!

It suddenly dawned on me – as I was filling up the gas tank in Erath – that the while stuff mixed in with the rain coming down wasn't 'rain', but sleet and snow! Yuk! Shades of the January trip. Time to really zip home, trying to be back home by early afternoon. The net seems to fade away on Sunday afternoons many weekends (football?), and lack of net control.

It seems Mother Nature decided to dump on Dallas that weekend. Plano got more than 4 inches of rain in 24 hours, and just to the east (on the interstates) they had over 9 inches of rain. One of the locals said he had S9 plus rain static most of Saturday night into Sunday, as he was 'contesting' on 10m. I hit the heavy rain just east of Taylor Co, (Abilene). Now a little rain isn't bad, but this rain, wasn't fun. The rain static was 40 dB over S9 most of the time the entire way home. It dropped when I went under a bridge (no rain for a second) or when I slowed down under 20 mph. Otherwise, it was 10% copy of what was happening. No way to run counties in that. I couldn't even hear either net control.

KC1NA had to drive through all of it – I could stop in Dallas! There is no fun 'having' to drive in any type of weather, no less torrential downpours, highway flooding, and the idiots who don't slow down and wind up in the ditches all along the highway (dozens of them). Glad I don't 'have' to drive. My hats off to those that do

Fortunately, I had run the county pairs on the way out, and KC1NA had run all the interstate counties on Sunday, so there weren't any missed counties along my route for anyone listening. Serendipity! Five hours later, having listened to rain static nearly all the way home, with an occasional lull where I caught N8STF up in Michigan in some needed counties, I arrived home.

However, we got the last counties, got Eldon everywhere up in the UP to clean that up, and made over 1000 contacts, in 950 miles of driving. The next time I want to go out in the winter, sometime remind me about 'snow and ice and sleet'. Maybe I'll just run the net for a few hours that weekend instead!

MEMBERS for the COUNTY HUNTER OF THE YEAR Award. If you wish to be nominated or want to nominate another MARAC MEMBER please contact your DISTRICT DIRECTOR to start the process with your selection. Below are the guidelines for the award. All nominations must be turned into your District Director and he MUST have the final list of qualified nominates submitted to the Awards Manager no later than April 1, 2002.

This award is issued once each year in the form of a County Hunter of the Year Plaque to a deserving licensed radio amateur and current MARAC member in two categories, CW and SSB. Nominees not winning will receive a certificate. The recipient will be selected from nominations received by District Directors and cannot be a previous recipient of the award. Nominees should be considered for their activities in each of the following areas on an on-going basis primarily during the past year:

- 1. Overall quality of operation while mobile.
- 2. Overall quality and quantity of operation as a Net Control Station (NCS) or assistant NCS.
- 3. Participation in the activities and support of MARAC.
- 4. Other work performed in support of county hunting.
- 5. Technical proficiency in design or usage or implementation of enhancements to mobile operation or county hunting net operations. Overall amateur radio general support in a manner consistent with good operation and advancement of the hobby. Nominations must be received by the District Director not later than the end of the fourth month preceding the annual convention or by the deadline announced in the Road Runner. The District Director will select one nominee from both CW and SSB and forward that selection with the reasons for the

selection to the Awards Manager by the middle of the next month. If more than three nominations are received for either category, the Awards Committee will select three nominees for each category for the ballot using the previously stated criteria. If less than three nominations are received, the Awards Committee may name other nominees to bring the level up to three nominees for the ballot. Actual selection of the County Hunter of the Year will be by mail ballot sent with one of the pre-convention newsletters.
