# The Perils of GPS By: Tim, KD5CXO

The trip to Harlingen in February was designed to add significantly to my list of transmitted counties in Oklahoma and Texas. The plan was to put out 55 counties on the way to south Texas and 44 counties on the way back. Using the Street Atlas program the first check was the distance from Mountain Home to Harlingen through Oklahoma City. The distance was 1082 miles. Then I started to add the "via's" (or waypoints) to force the route through the counties that I needed to put out. Great care was taken to find the "shortest" route, I don't mind using the back roads as long as they are paved, so we traveled mainly on State and County roads and occasionally a Farm to Market road. I pared the zigs and zags down to 1332 miles for the trip down. Not bad, 55 new counties transmitted for 250 extra miles.

One of the problems driving a motor home pulling a Jeep is that you can't park on county lines, so we didn't plan on putting out county lines. Stopping at Wal-Marts to let Faith go shopping while I worked the radio was the general rule. Other stops to walk the dog worked the same. We can never plan on where

we are going to stop for the night, some days we travel 150 miles, other times 250. Then there's the exception: traveling southwest out of Oklahoma City in the late afternoon we decide to try to find a campground around Lawton OK. There was none, so in a last ditch effort we resigned ourselves to a stay in Wal-Mart's parking lot. Getting there after dark we found Wal-Mart was "downtown" with a tiny parking lot full of soldiers hanging out from the nearby fort. Back on the road Kent KL1V kept us company for many hours into the night. He was often the only contact for a transmitted county not exactly what I had planned. Southeast of Wichita Falls, TX now some 350 miles later, we finally found a campground. We pulled in as quietly as possible and paid the owner the next morning.

The first seven or eight counties went as planned the next day – and then – and then as we clipped the corner of a county, put it out, and took a short cut to the next, the pavement suddenly ended and an open gate crossed the road, a sign pronounced "end of state maintenance" and another said "no trespassing." I looked at the GPS display; clearly the road went through and connected to a state highway just a few miles ahead. Well, in Arkansas the law says you cannot prevent someone from using a road to cross your property. But in Texas trespassing is a serious offense that can get you shot. We had no choice but to turn around. The road was narrow, so I had to get out and disconnect the Jeep, wiggle the motor home around and reconnect the Jeep. The backtrack lost us about 50 miles, so much for that short cut.

The next two days were as planned, the GPS tracked us through some of the most forsaken land I've ever seen, West Texas desert shrub and a few goats. Then on the third day about mid afternoon, we found ourselves in Hondo, TX. It was time to look for a campground somewhere down the road. Much to our dismay there was none between here and the Rio Grande, 175 miles distant. Hondo had two so we decided to go no farther today. However, we found that one "campground" was a field with broken down trailers and the other was a "fishing camp" that wasn't as good - it was decision time. To heck with the GPS and the planned route – let's take off east back to civilization where we knew there were campgrounds. Choke Canvon State Park welcomed us about 7 PM. Next day on to Harlingen, no new counties to transmit.

We had a great time at the mini, but that's another story. The return trip was again planned with the GPS to go through some counties in east Texas where there were holes in my transmitted county map. One place I had figured by using back roads I could put out five counties in 20 miles. Under my breath I was daring net control to ask if I had a magic carpet, but he didn't. Then the rains came, for three days it rained with no let up in sight. The trip through the Sam Houston National Forest was the next challenge. They didn't tell me that "road work for the next 8 miles" meant that they had removed the entire pavement for the next 8 miles. No room to turn around and in fact I'd better not stop, the mud was 4 to 8 inches deep. I would never get out of here if I lost my momentum. Fishtailing and spinning tires finally got us through. The Jeep had changed colors from dark maroon to bright orange. The motor home was no longer white and blue but now matched the Jeep.

Now GPS, where is the nearest town we can find a car wash? A 40-mile detour off the planned route and there I was – washing the vehicles in the rain; funny, I was the only one in the car wash!

The weather report the next morning was not good, an ice storm had hit Dallas and the Interstate was closed, one person killed. Well, our planned trip would take us close to Dallas, so another change of plan was in order. Forget the two remaining counties I needed transmit, let's turn northeast toward home. And then there's the story of someone needing Yell County for the last in the state. The short cut across the Ouachita Mountains to Yell was shorter but took us three hours longer to get home. In the mountains and as we neared home we noticed that the rain which they had was the white kind.

So, there it is -a fine adventure -don't you think you'd like to use a GPS -it's fun!

## On the Road with N4CD

"You never know where N4CD will pop up" often sums up the N4CD travel philosophy! Sometimes I don't even know myself until I get somewhere. There are many things if life I'm interested in, and county hunting is just one of them. As part of my trip planning, often I will try and combine more than one activity. That keeps things interesting, and some days the propagation is "just plain rotten", or it's time to Also, having a goal other than take a break. 'burning gas' while driving a thousand miles or more sure makes sense to me. Killing three or five birds with one stone is a nice goal. Some days, I don't have enough time to run all the counties on CW and SSB if it's a weekend and 100 county hunters are trying to work me! Other times, no one seems to need your county. You never know. So most of my trips these days are multi-purpose.

You will often hear mobiles on the net on a trip – visiting friends, children/parents, headed off to a convention/meeting, or on 'vacation'. Some days you will hear KI0JD, WA4UNS, N9STL, AC4XL, or other mobiles go out to run part or

all of a state, but that seems to happen less and less often these days. I've done that before – run 150 counties in 7 days of driving! That's helped me put out lots of counties for the folks on the net. Also puts lots of miles on the car, as WB9OOG, KI0JD, WA0SBR, N4UJK, and KC4UG can tell you (all members of the 150,000 plus miles of county hunting group!)

During the past year, I've had some great fun – lots of ham meetings and conventions to go to – Harlingen, Dayton Hamvention, the Bell County Hamfest (twice a year!), the annual northern trek in the summer, and, my main hobby – telecom/telegraph history. Several other county hunters are train buffs and head out each summer to visit/ride some of the historic railroads around the country. Some go 'treasure hunting'. The Durango/Silverton narrow gauge RR is a fun ride, in rare San Juan County, CO!

In 2001, I accidentally discovered the Mariner's Museum in the Hampton Roads area while at the National Convention. If you watch the 'History Channel', you will recall they are involved in the preservation project of the Now they have the ironclad Monitor. propeller/shaft, a hundred or more 'artifacts', plus will soon have the then state-of-the-art steam engine. While there, I found they have one of the world's best maritime libraries (catalog on line, too) including some very rare volumes on submarine telegraphy! Of course, running counties to/from the convention results in lots of net congestion, but I still transmitted from nearly all along the way, some with 1 contact, some with 50. Everyone else had the same idea.

Last summer it was off to New England, at the old N2TPH QTH, where I made many small trips around, and one big plane trip to Newfoundland, Canada. The I.E.E.E. sponsored a History of Telecommunications 3 day seminar, and it was held in St. John, where Marconi received the first wireless signals across the Atlantic 100 years ago. A special museum contained the original receivers, original kites used to hold up the 'long wire' antenna, and other significant items. I got the radio-operating bug, but only had a 2m handheld with me – hard to work "DX" with that. However, a commemorative station, VO1AA, operates from Signal Hill. You could be a 'guest' operator there! That solves the 'withdrawal symptoms' from not being near an HF radio.

Later in 2001, one of the guest ops worked N4CD/m on the CH net! (Fortunately didn't get yelled at for using phonetics!). Now I have that special QSL card to add to the collection.

One of the best radio museums in the world is the Antique Wireless Association museum in western NY. Try and visit during the national convention in September. They have thousands of working old radios, from spark gap to gold plated (literally) showpieces in two large buildings.

Recently, I went to the Smithsonian in Washington DC, to see the new "Undersea Web' exhibit (submarine telegraph/telephone history/technology). Everything from Morse's original telegraph equipment up to state of the art fiber systems. Of course, the Smithsonian has thousands of exhibits on just about any subject area, so something will appeal to everyone. When you are there, visit NN3SI, and perhaps be a 'guest operator'. NN3SI showed up on the County Hunter Net and made a few HF contacts while I was there! (See a trend here? Guest op at interesting stations!).... I've done visiting operator that at a few of the 'big' county hunting stations, and it is a lot different having big beam/big amp compared to county hunting with a barefoot rig and a little vertical/dipole!

In county hunting, since counties count from anywhere you are, even a Dx-pedtion trip let

you work counties. Andy, VE2EM, visited Costa Rica and ran in the CQ WW CW contest making thousands of contacts. NV4Z and N3ISH went off to the Caribbean and worked thousands! You can work mobiles on the net. SSB/CW/RTTY/PSK31, whatever vour preferred mode. All the contacts count. The 20,000 CW contacts made by N4CD in 2001 while off on overseas trips, all got checked for their counties, and added to the totals for CW and SSB awards! Someday I'll finish off USCA, all CW.

We are now into 2002 – another year to plan dual-purpose activities, and work toward the county hunting goals I've set for myself. How about you? Going to do that activity you've been putting off? Any places you want to visit or see? From Pearl Harbor to Duck Harbor to Bar Harbor, I've got lots of places to go, counties to run, and museums to visit. You never know where N4CD will pop up!

# **President's Corner**

I have had a week now to mull this over in my mind sitting in the hospital again – I am running out of things to write about... I can go back and write about how we (MARAC) do not run nets and all that, but I have not gotten one letter in weeks until today about bad ole Jim... And the one today was not only about bad ole Jim but calling for my resignation as well as our NL editor because he called WR a "Rag"... Gee, and I thought the term rag was slang for newspaper. Guess he took it wrong... I will not go into detail of how disappointed I am in Ace and his article in WR. The doctor put me on antibiotics and things seem to be getting back to normal. This is something I will have to live with, and wont get much better -Ihave to be aware when I get short of breath and go see him right away (not wait weeks for it to progress like I did). Treatment normally would include steroids, but at my size he doesn't want to do that.

Gee, I must be getting old - writing about ailments and all... but this gave me time to reflect on what is going on around us and how insignificant the ongoing saga on 14.336 is compared to the world in whole. After all only six months ago our whole world was turned over by some crazy people by flying into buildings. We are now sending our youth into harms way to get rid of them (from there, then where next?)... But life must go on. Six meters is closed now until summer and hopefully E's season will bring some activity, but nothing like last fall. I have lost interest in listening to the TU-TU net, but have been actively chasing some counties and DX on the WARC bands. Our oldest daughter is getting married in May and that has been all time consuming (as well as expensive).

#### A: Awards rule changes.

The Board Approved the following rules changes as submitted by Gene (KD9ZP) and the Awards Committee.

#### **Replace (In the Award Rules):**

Awards to hams are made for valid twoway radio contacts with other amateurs. Only direct signal report exchanges constitute valid contacts. Reports using other than numerical signal reports (such as "bang, bang rifle shot") are not considered valid contacts.

With: MARAC awards require direct two-way radio contacts between licensed amateurs. Valid contacts must include an exchange of signal reports or other information between the two stations.

#### **Replace (In the Award Rules):** BEST NET CONTROL and BEST MOBILE OF THE YEAR AWARDS

A MARAC Special Plaque is issued each year to the "Best Net Control" and "Best Mobile" in each of two categories: SSB and CW. Selection will be by quarterly mail ballot of current MARAC members. Winner announcements will be at the annual convention. The same amateur may win either award more than once. There is no fee for this award.

With: BEST NET CONTROL, BEST MOBILE, and BEST MOBILE TEAM OF THE YEAR AWARDS

A MARAC Special Plaque is issued each year to the MARAC members who are voted "Best Net Control" and "Best Mobile" in each of two categories: SSB and CW. MARAC Special Plaques are also issued each year to the two MARAC members who are voted "Best Mobile Team" (SSB only).

A mobile team may consist of any two MARAC members who operate mobile and give out counties together (including teams not eligible for the OM-YL team contacts).

Selection will be by quarterly mail ballot of MARAC members.

All recipients and voters must be MARAC members in good standing.

Winners are announced at the MARAC annual convention. Amateurs may win these awards more than once. There is no fee for any of these awards.

#### The rest remains then same:

The annual Best Net Control - CW award will be known as the Paul Edmonds W8RYP Memorial Award. Paul was an active Net Control on the early CW county hunting nets, especially on 40 meters.

The annual Best Mobile - CW award will be known as the Mike Mutnick KV0E Memorial Award. Mike was a two-time winner of the CW Mobile of the Year Award and was tragically murdered by hitchhikers while on a mobile trip in New Mexico in 1984.

Second and Third place winners will receive an appropriate certificate.

**B: Ballots** The subject of the ballots not being included in the March RoadRunner was discussed, Dave (KF4KW) explained that they were inadvertently left out of this last issue. Ballots will be with the next RoadRunner.

**C:** South Central Mini Joyce (WB9NUL) reported that the SC Mini went off very well and all those that attended had a great time.

**D: Future National** Joyce (WB9NUL) polled the board as to there feelings about holding a future National down in South Texas. All present were in favor.
