LaSalle Mobile

The mystery is solved! Remember the pictures from last month? As Paul Harvey would say, here is the rest of the story.

If you worked AD0H/mobile between August 5 and 12, you may have heard me sign "LaSalle mobile." I know that the net disdains idle chitchat but you have to admit that it isn't everyday that you work a county from a 1939 LaSalle 4door Series 5019 with a 322 cubic inch flathead V-8 engine and 16 inch wheels. The car belongs to my brother, Don (W7NG), and we were driving it from his home in Seattle to the Cadillac-LaSalle Club Grand National meet in Denver, 1400 miles away. The route went from sea level to mountain passes as high as 9,658 feet and back down to lava fields and desert heat. These conditions were challenging for radio operating and for Sally (many LaSalle owners call their cars Sally), but a lot more fun than driving a modern air-conditioned anything on faceless freeways.

This was the second time I had operated mobile from the LaSalle. As I did in 1999 when the grand national was held in Santa Clara, California, I flew to Seattle two days before departure to allow time to install an antenna, rig, and a battery. Most of the county hunters are old enough to recall when cars ran on 6-volt systems, requiring the borrowing of the 12-volt battery from Don's everyday Nissan. Also packed along was a battery charger, which was hooked up every second night in motel rooms along the way. (Yes, I had to carry the battery upstairs several times. The things we put up with in the hobby.)

The antenna was a Hustler 5-ft. whip (which I had stored at Don's after the first trip), with one of Barry's 20-inch extensions (making the antenna a significant 33% longer), with the bracket for holding three loading coils. Other members of the car club said the antenna resembled a "music stand," and they had a point. The "where to mount it" question was easy. In the days preceding fiberglass, bumpers were made of steel and were bolted to a steel frame, providing a much better ground-plane system than today's cars. However, Don had recently had the bumpers re-chromed, as part of the on-going restoring project, and scratches were strictly discouraged. So I wrapped a 2inch width of the bumper with cloth, and wrapped that with duct tape, and then fitted the steel strap of a Hustler bumper mount around that protective, but insulated, cover. A ground jumper made from the shield of a piece of coax completed the circuit to the frame of the LaSalle. A quick disconnect and the heavy duty spring (much stiffer than the Hustler version; I wish I could find more of these) completed the antenna. The coax was fed through the lip of the trunk and snaked into the back seat of the car. This crawling around in an old trunk and shifting the rear seat to reach the cable is always the hardest part of an installation.

I packed the antenna parts in my checked-in luggage, including a clear plastic peanut butter jar of nuts, bolts and connectors, and carried an Icom 706-II in a shoulder bag. The 706 makes up in small size what it may lack in intuitive operating ease; it drew no attention at any airports (although recent security measures may encourage me to add the rig to my checked-in bags the next time).

In the 1999 trip, operating enjoyment was curtailed by noise. Those old cars put out ignition, generator, and tire noise, and it was especially harsh on 20 meters; 15 meters was much quieter, but not open as often and no county hunters net. Another Seattle ham told

me about seeing a demonstration of the ClearSpeech digital noise filter. For \$150, it seemed worth a try-and it was. (A special thanks goes to Stacy at Am-Com, who arranged for a last minute Fed Ex Saturday delivery to Seattle after the brown truck didn't make its three-day guaranteed delivery before I left.) At highway speeds, only the very strongest stations were intelligible without the filter, but with it, I could hear anyone who could hear me. The audio sounded a little processed (because it was) and there was a loud rush of sound when switching from transmit to receive, but the little box plugged between the rig and the outboard speaker (and hooked to the 12-volt battery) spelled the difference between many contacts and frustration.

I learned patience operating in the mountains, when stations would fade out before a QSO could be completed. The net learned patience with me, such as the time I announced I was on the county line of Teton and Park, Wyoming. On the map, the line appeared to coincide with the Continental Divide, and we parked right beside that sign, but about a halfmile down the road, here was the sign for the next county—and it was Fremont, not Park. Thanks to net control for announcing the correction to the stations I had just worked. Those things happen.

I also mustered enough courage to try mobile CW again and with better results. It had been several years since the last CW attempts, when I couldn't keep up with the speed demons and keep my eyes on the road at the same time. (OK, maybe those guys are just better CW operators than I am. And from frequent use, those special Q signals were familiar to them, too.) In August, the net members seemed more relaxed and accepted my somewhat sloppy procedures. My CW operation was interrupted for several days when the parts of my Vibroplex paddle came loose and I was convinced that I had lost the small springs in the seat cushions. I

missing after all. On the Sunday we left Denver for the return trip, I became a CW fan again, and worked 18 countries on 15 and 20 meters during the Worked All Europe contest. Ten meters provided no contacts then or anytime on the trip.

In total, I made 337 QSOs from 35 counties in 6 states. This was six times the 56 contacts made from the LaSalle two years prior. I've had longer runs with better conditions and put out rarer counties from the Midwest, but never from a 1939 LaSalle.

Newbie's Testimonial

As a teenager in the mid fifties, I desperately wanted to be ham. Immaturity got in the way, however. No matter how much I listened to those AMECO records (anybody remember them?) I never did get the code down for my Novice ticket. I settled for intense SWLing and enjoyed it thoroughly. The years passed with college, marriage, career, kids and grandkids. Finally, in 1998 I was mature (in all respects) enough to think about ham radio again. I started out as KF4ZDP and did the HT/repeater thing for a while. I soon realized that the thrill of SWLing back in the fifties was hunting down those rare DX stations and getting QSL cards. (I wish I still had all those specialto-me cards.)

I quickly began the upgrade route, saved some money and bought a 706 so I could chase DX again. What a thrill to snag some of those rare ones — like Clipperton Island. I Worked All Continents, got my DXCC with great difficulty. I tried to get Worked All States but found that too many US hams didn't bother to return QSL cards.

I joined a local club but found it to be too social and too political. Another club was struggling but wanted to emphasize overall ham radio and education. They got me into ARES, class teaching and VE testing, field day and JOTA, among other things.

What's all this have to do with MARAC? Glad you asked. One our club's project's is to raise money to build a complete HF/VHF station for the local Boy Scout camp which serves about 2000 Scouts every summer. About this same time CQ magazine Awards Column had an article about a Worked All North Carolina counties certificate. Hey, that's not a bad idea for our club! After checking with Ted Melinosky (K1BV) and others, we decided to go ahead with a Worked All South Carolina certificate. I still didn't know much about county hunting. What could be the big deal? Little did I know! I had tried APRS and found it wanting. PSK-31? Not sure yet. I-Link? Nah! One day in late February I decided to listen in to the net on 14.336. Whoa! This sounds cool. Let's see what I can do here. I threw out my call — Kilo Uniform Four Yankee Mike. I made the contact, exchanged the signal reports and then slam! Jim, KZ2P, quickly told me, " don't do that here. No Phonetics!" I thought, "What's going on here? Phonetics are de rigeur on DX! I may have screwed up some more but I did get the hang of it even if I was afraid to make many more contacts that day.

Thankfully, Doug, WA4UNS, quickly sent me a very encouraging e-mail that same morning introducing me to the net etiquette, web sites, MRCs and MARAC. Less discouraged, I decided to check all that out and try some more county hunting. What the hey, if I'm going to try this I ought to support the organization. I joined MARAC. About this time I got the World Radio with Ace Jansen's article. What I have done? Do I really want to be involved in all this?

Then I though back a bit. When I first started chasing DX I also got slapped around a bit — and learned fast! If you want to get on a list on the 14.247DX Net, you'd better throw out your "last two" and you'd better use standard phonetics. Then the contacts require the full call — with standard phonetics. Each Dxpedition I've worked has had it's own routine. The most recent DXpedition, Ducie Island, wanted full calls only. The long and the short of it is, "When in Rome, do as the Romans do," wherever you roam. The operative word in "net control" is "control," not net.

From what this newbie can see, the county hunters net is superb. MARAC is a super organization. And more importantly, the people are warm, friendly and giving. I started from zero and I've already made over 200 contacts in one month and most of them are already confirmed! I don't know if I'll ever make USA-CA the first time, much less Jim's 7 times but I'm sure going to have fun trying! I'm already contemplating putting a rig in the car so I can give back some counties.

Thanks to Jim, KZ2P, for setting me on the straight and narrow path, to Doug, WA4UNS, for those encouraging words, to Dennis, KK7X, for helping me solve the AOL problem with the MARAC Members-Only Page and to all you mobiles who make this the exciting sport it is! I hope I can meet you all face to face someday.
