## MARAC Logger Update KD9ZP, Gene

Over the past several months I have received many questions about the status of MARAC Logger. Hopefully, this article will answer many of these questions.

I have been working on MARAC Logger for almost three years. K7DM, KD5CXO, WQ7A, and several other county hunters have also been actively involved in developing and testing the program. When I volunteered to take on the project, it was my goal to integrate it with the MARAC database already on-line at <u>www.marac.org/database</u>. This meant that MARAC Logger would have to use Microsoft Access 2000 as its database, which in turn meant that the program would have to have the capability of converting Kwiklog data to Access 2000. The data conversion has proven to be much more involved than I expected. There are four versions of Kwiklog:

- Kwiklog Lite
- Kwiklog Plus
- Kwiklog Plus 2000
- Kwiklog Classic

We discovered that the record lengths for data are different for each version of Kwiklog, which made the data conversion routines significantly more difficult. We also discovered that there are a number of bugs in Kwiklog that also complicated the conversion.

All the versions of Kwiklog have two sets of data, the so-called "dot qso" files (files with a ".qso" extension) and the 50 two-letter state files (AK, AL, AR, etc.). The dot qso files contain data pertaining to each QSO, such as date, time, call, state, county, band and frequency, mode, and the exchanged RSTs. The two-letter state files contain some of this data, but also have data pertaining to the various awards (also referred to as "books").

The MARAC Logger Access 2000 database contains many sets of data called "tables." For example, there is a table for QSOs, a table for each of the various books or awards, a table for individual county hunter information, etc. The QSO table is very similar to the Kwiklog dot qso files. The book format MARAC Logger uses is considerably different than Kwiklog. MARAC Logger has an Access 2000 table for each book, i.e. there is a CW table, a USA-CA table, etc. Each book table has two fields, County ID and QSO ID. One advantage of using Access 2000 is that it references data by an ID number. Every county hunter has an ID number, every QSO has an ID number, and every county has an ID number. This scheme provides rapid access to an individual record and takes less disc space.

The Kwiklog data conversion continues to be a problem. We have found many errors in the Kwiklog files, the most common of which is a Kwiklog book file with an entry that does not correspond to an entry in any dot qso file. In this case, MARAC Logger creates a QSO entry for the book entry. WQ7A, K7DM, and KD5CXO have found that it is often easier to fix a bad entry in either the Kwiklog dot qso file or the two-letter state file and then rerun the conversion. WQ7A has developed an Excel spreadsheet with Visual Basic macros that identify and locate book errors so they can be corrected in Kwiklog *before* the conversion. It's called KwikLog File Viewer and is available at no cost at: <u>http://superhosts.net/~wq7a/</u>. It requires MS Excel version 2000 or later. You can download it and check your data to find possible errors.

I met with several members of the MARAC Board Of Directors at the national convention last July and we decided the fee for the program should be \$20 for members and \$40 for non-members. All program proceeds go directly to MARAC. We decided to limit the number of users for the initial release to five in order to limit the number of questions and potential data conversion problems. The target date for this release is January 1, 2006. If you have any questions about the program, please direct them to K7DM or WQ7A.

September 8, 2005

The meeting was called to order by Joyce (WB9NUL) at 8:02 PM EDT. The following Officers/ Directors were present:

Bill (K2NJ) made a motion to accept the minutes of the Roanoke, VA Annual Meeting. The motion was seconded by Jim (KZ2P). Role call indicated 5 in favor none opposed. The motion passed.

Bill (K2NJ) made a motion to accept the July 2005 and the August 2005 Treasurer's reports. The motion was seconded by Don (AE3Z). Roll call indicated 5 in favor, 1 abstention and none opposed. The motion passed.

#### **New Business**

On a motion made by Jim (KZ2P) and seconded by Bill (K2NJ) the annual report was accepted. Roll call indicated 6 in favor and none opposed. The motion passed.

Bill (K2NJ) made a motion, seconded by Jim (KZ2P), to accept all of the modifications to the MARAC awards that were presented to the Board and Members at the Annual Meeting by Dave (KE3VV). Roll call indicated that 7 were in favor and none opposed. The motion passed.

Norm (W2IBB) reported that hurricane Katrina completely demolished his house. He was able to save the MARAC records that were stored on his computer, but all other paper records, checks for dues renewals/new memberships along with all other historical paper documents were lost. His membership data base is current to August 25, 2005. The Pass Christian Post Office was also completely demolished and there is a very good possibility that some checks for the renewal of dues and new memberships were lost. The Board of Directors agreed to extend the membership expiration date of all those members whose membership are/were due for renewal in August and September until these members are notified of the situation. If checks are not received within a reasonable time, Norm will inform the members of the problem and ask them to forward replacement checks. The Board agreed to give Norm some latitude in this matter. Joyce agreed to publish a notice in the next Road Runner.

#### Changes to the By-laws

Bill (K2NJ) made a motion, seconded by Jim (KZ2P), to clarify that Article 1.2(a), (b), and (c) apply only to District Directors and to clarify that a person may not hold more than one seat one the Board at the same time. Article 2.1 is also amended to clarify that no one may hold more than one officer position concurrently. These changes will allow the footnotes to the current version to be deleted Roll call indicated 7 in favor none opposed. The motion passed.

#### Page 6

Jim (KZ2P) made a motion, seconded by Don (AE3Z), to amend Article 1, Section 1.3(e) to allow all meetings of the Board of Directors, including the annual meeting, to be held by radio, Internet, or conference call. Currently, only special meetings of the Board can be held via the Internet or other alternative means. Roll call indicated 7 in favor none opposed. The motion passed.

Mike (W0MU) made a motion, seconded by Don (AE3Z) that the provisions of Article 3, Section 3.3 are amended to allow more flexibility in the voting process, including the use of electronic ballots and the MARAC web, and to require the Election Coordinator to maintain voter identity separate from tabulated votes. Roll call indicated 7 in favor, none opposed. The motion passed.

Norm (W2IBB) made a motion, seconded by Mike (W0MU) that the provisions of Article 8, Section 8.2 are amended to avoid a conflict between the ratification process for amendments to the MARAC Bylaws and the revised elections process. This will allow the use of electronic ballots and the MARAC web site. Roll call indicated 7 in favor, none opposed. The motion passed.

There was no other business to discuss. Bob (KC6AWX) made a motion to adjourn the meeting at 8:30 PM. The motion was seconded by Bill (K2NJ). Roll call indicated all in favor, none opposed. The motion passed.
