## **Dateline CW**

The sublimest song to heard on radio is CW from a county hunter on a rare county line.

The big event this month is the Southeast mini convention at Mount Pleasant, South Carolina. I have not been able to attend conventions lately, but I plan to attend this one and be part of thirty-two plus already signed up. Hope to see you there. Check the MARAC website for the Mini details.

I stopped at the Piscatorial Fry-a-Torium on Bay Street and purchased some crispy fried Mullet back-bones and fresh Tartar sauce. I have QSO party logs to compile so I might as well enjoy the process. I open the cooler and get a frosty lager; now where is the sea salt? I will be glad when Gator gets back from his ACE meeting.

Last month there were three State QSO parties on one weekend all on the same center frequency. That made it easy for the VFO tuning impaired. The South Carolina QSO party was a bust for me. I heard and worked only one CW station. I was able to hear both the Colorado and Washington State QSO parties on CW on 20-meters. I got three new counties in Colorado and eight in Washington. I heard no Colorado or Washington stations on 80-meters.

I also picked up a few new ones in the Tennessee QSO party, but not even close to Jerry, W0GXQ, who got 22 new ones on 80-meters,. I was hoping to work Norm, W3DYA, in the Arkansas QSO party, but he cancelled the trip due to inclement weather scheduled for the area. Norm operated in the Texas QSO party and what a blast, I need to get started on those logs. A county hunter never rests.

This month the county hunting fun continues starting with the California QSO party, the granddaddy of QSO parties second only to Florida. Look for California stations on 10 and 15-meters, as the bands open for this contest, and a chance to increase your county challenge top list totals. I have worked all the California counties on 10, 15, and 20-meters most obtained from working this QSO party. I need only Calaveras and Tulare to complete 40-meters. I will be there.

October 10 is the ten-ten international net Sprint. I will be doing CW around 28.038 MHz. Hope to hear you. You will hear county hunters mobile in the Illinois and Pennsylvania QSO parties. At the end of the month on the way home from the Mini convention I will be running on 10-meters in the ten-ten CW QSO party. So come up and listen every once in a while around 28.038 MHz. We are getting into the amateur radio contest season, are you ready? I finish off the last Mullet back-bone, Give it a lager wash, and now for a short nap before I go trick or treating.

Hooray! I did it . . . I finally finished working all 3077 counties in the good old U.S. of A. It took me four years to do it thanks to the declining sunspot cycle and the fact that I'm still working. However, with the help of all the good folks out there and the encouragement of my husband Matt, WØNAC, I now have my USA-CA All Counties award framed and hanging on the wall next to his.

Neither of us had ever heard of county hunting back in 1960 when at matt's urging I got my Novice ticket (KN8WHW) in dayton, Ohio. He's a hard task master as an Elmer. He insisted I not just memorize answers to exam questions, but that I actually learn and understand radio theory, etc. By the time I got my code speed up to the required 5 wpm and passed my test I was able to design and build my own transmitter, even down to fabricating the chassis!

I had a couple of memorable experiences during that year, both having to do with CW contacts. One evening I answered a CQ and in the course of our "Chat," the ham on the other end told me his roommate was from the same hometown as mine and he turned the key over to him. Imagine my surprise (and shock) to discover that his roommate was an old boyfriend from several years earlier! On another occasion I was awarded a Rag Chewer's Certificate for a CW contact that lasted an hour or more.

About the time I needed to be studying to upgrade my license, the Air Force put Matt back in the cockpit and he was gone most of the time. I had two bables in diapers then, and I didn't have the time nor the energy left to pursue radio, so my Novice license expired and life went on.

After matt retired from the Air Force, we moved home to Colorado. Around 1999 he discovered county hunting and set up a mobile rig, as well as the base station at home, and I became the official logger on the road. It didn't take long before he began nudging (nagging) me to get my license so we could work as a team. I'm the minister to the senior adults at South Suburban Christian Church in Littleton, and I kept telling him I didn't have the time to devote to studying for the exams. Remember the

That's quite a feat with a little dog on my lap, a three-ring notebook and microphone in my left hand, and writing furiously with my right hand, especially if we're putting out a county on the fly.

What a great hobby this is. I wouldn't take a million for the fun and unusual and sometimes alarming experiences we've had over the miles we've traveled. In August 2007 Matt and I celebrated our 50th wedding anniversary in Hawaii putting out five counties while enjoying gorgeous scenery.
