Thanks to all of you for your time and effort spent in the pursuit of our hobby.

Let me welcome some new people on board to MARAC. First, Leo WY7LL was elected Vice President. The KL1V appointment as Election Coordinator has been approved by the Board. These folks will add additional strengths and view points to our club. KC6AWX has stepped up and volunteered, and I have appointed him to become our new Awards Manager. Under the MARAC Bylaws, the appointment is effective when made, and I will ask the Board to ratify the appointment at the next BOD meeting. Bob is well versed on all the programs that are used to maintain the Awards program and will continue what past award chairpersons have added to MARAC.

And now to some other important MARAC business. We need your input on a controversial decision. Let me explain. The "Annual Meeting of MARAC" is a Board of Directors' meeting held at the National Convention. In the days before that meeting, I received conflicting pieces of information concerning the approval of the Master Diamond Award and its start date. The Awards Committee had worked long and hard to develop and fine tune the Award before it was submitted for approval. That's always a lengthy and tedious process.

I learned that a number of persons who would be eligible to seek the award had been assured that the "start date" would be two years ago, in June, 2008, and had been making contacts toward the award for some time. That seemed odd, considering that the award had not even been formulated at that time... let alone approved. I also found that a majority of the Awards Committee had voted to reopen the discussion concerning the proposed start date but that the award had been sent for Board for approval



before allowing that discussion to occur. That, too was disconcerting.

I did a little research and found that when the preceding award, the Master Platinum Award, was first submitted for approval in January 2003, it was returned to the Awards Committee for additional revisions. When it was resubmitted to the Board in February 2003, a motion to approve the Award was defeated because of a similar start date issue. Another motion was made and passed at that meeting mandating the start date of this Award to be the date that the Board approved the Master Platinum Award. The BOD's thinking was, "How can one work for an award before it is an award?"

I agree with that concept but as the "Annual Meeting" time neared, I realized that there were strong opinions on both sides of this issue. Some of those voices were suggesting that "MARAC Headquarters doesn't listen to its members."

Just hours before the meeting I decided to make <u>sure</u> that the members of MARAC would have an <u>invitation to be heard</u> before the date issue is revisited. At the meeting I removed the Master Diamond Award from the meeting agenda. Let me say that it was my decision and mine alone!

I am asking you, the membership, to contact your District Director and entire Board with your opinion. Some individuals are advocating for a start date of July 3, 2008 – about the time the development of the new award began. Others would like the start date to be the day it is approved by the Board of Directors. Please let all those who vote know how you feel. I'd like to know too - even though I can't vote. Whatever the final decision, hopefully the members opinions will have been heard.

I want to say a few more things about the happenings of the last month. By what I receive in e-mails, phone calls and letters, it's obvious that some fantastic distortions of actual events and motives get posted on the internet or passed around somehow. I'm sorry that these things lead people astray in their thinking. When I hear or read these kinds of things, I go to the persons involved to see if there is another side of the story. I wish everyone did.

For instance, I was told and eventually confirmed by looking at the meeting transcript that an attempt to enter a motion via the internet was made at least twice during the Annual Meeting the instant the numbered agenda item referring to the starting date was reached. Later I was told I had no right to ignore a motion that was on the floor. In both cases, the agenda item was not read, and therefore no motion was entertained. The individual(s) who offered the motion(s) were out of order. I guess much ado was made of that. I'm sorry if I upset someone's applecant, but the only motion that can supercede all else is a motion to adjourn. The chair never recognized the motion(s) made and if I had known it was being made, I would have ruled it out of order.

One really laughable example is when somebody uses a term like "MARAC Headquarters," or other references suggesting that there is some conniving, conspiring oneness to the Club... as if the BOD is regularly huddled together, planning some sort of mayhem or retaliation. # MARAC Board of Directors Meeting July 10, 2010

The Annual Meeting of the MARAC Board of Directors was called to order at 1400Z by the President (Joyce-WB9NUL).

A motion was made by Cliff (AC0B) and seconded by Joyce (WB9NUL) to accept the minutes of the December 1, 2009 meeting. The minutes were accepted by a vote of 7 in favor and none opposed.

A motion was made by Jim (KZ2P) and seconded by Cliff (AC0B) to accept the Treasurer's Reports for December 2009, January 2010, February 2010, March 2010, April 2010 and May 2010. The reports were approved by a vote of 6 in favor, 1 abstention, and none opposed.

Jim (W9JL) and Barry (W9UCW) performed an audit of the Treasurer's accounts on May 16, 2010. All of the Treasurer's records were found to be correct and in compliance with generally accepted accounting practices. A motion was made by Dave (KE3VV) and seconded by Cliff (AC0B) to accept the report of the Financial Audit conducted by Jim (W9JL) and Barry (W9UCW) on May 16, 2010. The audit was accepted by a vote of 6 in favor, 1 abstention and none opposed.

## Old Business

A motion was made by Jim (KZ2P) and seconded by Carol-Ann (AB2LS) to hire an offsite vender to provide backup services and storage of all MARAC data contained on the Awards Manager, Treasurer, Secretary, and Data Manager's computers. After a discussion, the motion was amended. A substitute motion by Dave (KE3VV) and seconded by Jim (KZ2P) was made to allow the Awards Manager, Treasurer, Secretary, and the Data Manager to use an offsite vender (such as Carbonite) or an alternate source of backup and save all data on their respective MARAC computers. The motion was accepted by a vote of 7 in favor and none opposed.

A motion was made by Dave (KE3VV) and seconded by Chuck (AD8W) to accept the following revised

fee schedule for the LOGGER program. The motion was approved by a vote of 7 in favor and none opposed.

Jim (W9JL) audited the records of the Awards Manager. All of the Awards Manager's records were found to be complete, correct, and in order. A motion was made by Jim (KZ2P) and seconded by Chuck (AD8W) to accept the Audit Report. The motion was approved by a vote of 6 in favor, 1 abstention, and none opposed.

### **New Business**

A motion was made by Dave (KE3VV) and seconded by Chuck (AD8W) that MARAC will offer only email Road Runner subscriptions to all classes of new and renewing members under section 6.5(b) of the MARAC By Laws. The motion was approved by a vote of 7 in favor and none opposed.

Joyce (WB9NUL) appointed Kent (KL1V) as MARAC Election Coordinator. A motion was made by Dave (KE3VV) and seconded by Carol-Ann (AB2LS) to approve the appointment. The appointment was approved by a vote of 7 in favor and none opposed.

A motion was made by Dave (KE3VV) and seconded by Jim (KZ2P) to table the formation of a MARAC Recruitment Committee and nominate Duane (WV2B) as Chairman until the next MARAC Board of Directors meeting. The motion was approved by a vote of 7 in favor and none opposed.

A motion was made by Dave (KE3VV) and seconded by Chuck (AD8W) to confirm the purchase of a laptop computer for the Awards Manager. The purchase price is not to exceed \$1,700.00. The motion was approved by a vote of 7 in favor and none opposed.

A motion was made by Dave (KE3VV) and seconded by Carol Ann (AB2LS) to donate \$300.00 to the Michigan Mini. The motion was approved by a vote 7 in favor and none opposed.

The Awards Committee requests that the MARAC Board of Directors eliminate the Net Control Award. A motion was made by Dave (KE3VV) and seconded by Jim (KZ2P) to eliminate the MARAC Net Control Award. The motion was approved by a vote of 7 in favor and none opposed.

A motion was made by Dave (KE3VV) and seconded by Cliff (AC0B) to advance \$3,000.00 to Brian (NX0X) and Shari (KB0MHH) who are the co-hosts for the 2011 MARAC National Convention in Duluth, MN. The motion was approved by a vote of 7 in favor and none opposed.

Joyce (WB9NUL) removed the request from the Awards Committee as submitted by the Awards Manager for the approval of the proposed new Master Diamond Award. Noting that the Awards Manager had resigned prior to the Board consideration of the new Award and that appointment of a new Awards Manager is pending. The President will call for a vote on the Mobile Diamond Award after the new Awards Manager has been approved by the Board of Directors and the Officers and Directors obtain additional input from the Awards Committee and the membership on the new award. The President will request, in the next issue of the Road Runner, that the members of MARAC contact their District

Joyce (WB9NUL) cast the deciding vote to adjourn the meeting at 1452Z.



# **History Happens**


