### **Dateline CW**

A mobile CW county hunter has nothing to offer but miles, sweat, toil and counties.

I was discussing with Gator that I think I had what is called a phenomena. It had been dry for weeks and the 10-10 CW QSO party was coming up. I had added hundreds of radials to the tower with the Yagi to shunt the tower for 160-meters. I decided to wet the ground area containing the radicals and hope my chances of working stations on ten meters will be improved. I found my garden hose was not long enough and I was able to water only the East quadrant of the system. After the QSO party I had worked 200 contacts and not a contact in the 1, 2,3,5,8 and 9 call areas. I usually have many Ohio and Illinois stations in my log. I had only two QSO's in the 4 call area, one in North Carolina and a ham in the next county. Most of my contacts were in the West and Northwest and some DX. When I operated the radio did I get skewed by the half moist area? Gator goes to the cooler and gets a couple 807's and hands me one.

"This is a complex situation and requires liquid intervention since it might have been a different pattern had you been all wet. There is the ARRL ten meter contest coming up, wet only the West side and see if the East dominates. I think you will agree that correlation does not imply causation" "You got a good idea Gator; I will go to Wal-Mart and get more hose." Gator looks at my 10-10 contest log, "You got your last Oregon County, a 2x1 call and an 'N' prefix. I also see you got a bunch of new ten numbers. and a new county on ten meters. Not bad for a skewed signal." Gator is laughing as he sips his 807.

I change the subject, "Did you know the creator of Rocky and Bullwinkle died?" Gator gets a coconut bar, "No, they must have been county hunters before I was born." I again change the subject, "Here, run my ARRL sweepstakes log and see if I got some new counties." Gator runs the program, "Well, it was not a complete waste of energy. You got nine new counties on 80-meters, three on 15-meters and two natural bingo." I hand Gator my Kentucky QSO party log. He gives me the high sign. "You got 32 no-star counties, three natural bingo, five for fifth time and 10 new counties on 80-meters." "Thanks and there was a bonus mobile club station but it never made it to 40-meter CW." "That was a bummer; you would think a bonus station would be on all bands and modes. It is best not to have a bonus station." "You got that right."

I pick up some certificates off the desk, "Look, I got a certificate from ARRL for first place in the last year's 160-meter contest and the Sweepstakes contest, for single operator, low power, NFL section." "You must have been the only one in the section to send in a log." I give Gator the evil eye. I go to the loft to get the Christmas lights. Another December. Where did the year go? Gator is at the microwave. "What are you doing?" I am heating some turkey for sandwiches." "Anyone I know?" Gator gives me the evil eye. His cell phone goes off, "Dang nap it, there is a temperature recorder out on the reflux line, got to go." Gator grabs a sandwich and is gone like cash at an amusement park. He yells, "Merry Christmas and a Happy New Year." I hear the printer start. It is the list of mobiles heard on the CH county hunters' frequencies during November.

# MARAC Board of Directors Meeting December 1, 2010

The Special Meeting of the MARAC Board of Directors was called to order at 0102Z by the President (Joyce-WB9NUL).

### **Board Members Present**

President - Joyce Boothe - WB9NUL

A motion was made by Terry (WQ7A) and seconded by Dave (KE3VV) to accept the minutes of the September 16, 2010 meeting. The minutes were accepted by a vote of 6 in favor and none opposed.

A motion was made by Jim (KZ2P) and seconded by Dave (KE3VV) to accept the Treasurer's Reports for August 2010, September 2010 and October 2010. The reports were approved by a vote of 5 in favor, 1 abstention and none opposed.

A motion was made by Dave (KE3VV) and seconded by Jim (KZ2P) to accept the Awards Manager's Financial Reports for August 2010 and September 2010. The reports were approved by a vote of 5 in favor, 1 abstention and none opposed.

### **Old Business**

A motion was made by Jim (KZ2P) and seconded by Carol-Ann (AB2LS) to require the Awards Manager to submit a monthly financial report to the Board of Directors and to have it published in the Road Runner (similar to the Treasurer's Report). Also, have the Awards Manager's financial records audited annually prior to the Annual Meeting. The motion was approved by a vote of 5 in favor, 1 abstention and none opposed.

### **New Business**

A motion was made by Terry (WQ7A) and seconded by Bob (KC6AWX) to modify the MARAC Awards Rules concerning U.S. Counties QSO Party Rules (see below). The motion was approved by a vote of 6 in favor and none opposed.

U.S. Counties QSO Party Rules Sponsored by Mobile Amateur Radio Awards Club Objective: To establish radio contact with as many U.S. Counties as possible

Contest Period: Annually held during the last full weekend in July. Contest runs in two periods, from 1200Z Saturday morning to 0600Z Sunday morning, and begins again at 1200Z and ends at 2359Z Sunday.

# Contest Exchange:

<u>USA stations</u> send RS(T), State and County name, abbreviations are acceptable in CW mode. A list of suggested abbreviations can be found at the following URL's: Credit to Larry, W0QE for formatting, and

sharing for use

All other stations send RS(T) and "DX".

Categories:

Single Operator- One individual performs all radio operating, and logging functions.

- A. CW only-Only qso's made using CW (morse code) qualify for contest credit. If qso's are made using another mode, one may submit those qso's as a checklog without changing categories.
- B. Phone only-Only qso's made using voice modes qualify for contest credit. If qso's are made using another mode, they may be submitted as a checklog without changing categories
- C. Mixed mode-Qso's made using voice and CW qualify for contest scoring.

<u>Multi Operator</u>- More than one individual performs any or all radio operating, or logging functions. Only one transmitted signal on the air at any one time.

- A. CW only
- B. Phone only
- C. Mixed mode

<u>Mobile</u>- A station which is either in motion, or capable of being in motion. This includes transmitter, receiver, power source, antenna(s), and logging equipment. Mobile entrants shall be Single Operator only. Drivers O.K. See Miscellaneous, Item C for details

- A. CW only
- B. Phone only
- C. Mixed mode
- D. Multi Op Mobile (Must use one callsign for duration of contest)

<u>Mixed Category</u>-A single operator may choose to operate the contest both from one fixed or portable location, as well as a mobile. To qualify for this category, a minimum of 100 qso's must be made from the fixed or portable location, as well as a minimum of five additional counties must be activated as a mobile station. The county operated in as a fixed or portable may not be run as a mobile as well. See definition of mobile in the mobile category description.

- A. CW only
- B. Phone only
- C. Mixed mode

### Outside U.S.

A. CW only

- B. Phone only
- C. Mixed mode
- D. Bands: 160, 80, 40, 20, 15, 10, 6, and 2m are used in this contest. Phone qso's only in the Phone sub bands, CW qso's only in the CW sub bands. No cross mode, cross band, repeater, or satellite qso's permitted.

Suggested Freq's- CW 50khz up from bottom of band

Phone 1850, 3850, 7250, 14270, 21400, 28400, 50135, 146530 Mobile windows: 5 khz down from suggested freq. Please, if you are a fixed station, keep these freqs clear for mobile operations.

# Scoring:

### U.S. Stations-

Fixed- 1 point for U.S. Fixed, 2 Points for outside U.S., and 15 points for U.S. Mobile. While participation is encouraged for those outside of the U.S., please note, since the objective of the contest is to work as many U.S. counties as possible during the contest weekend, it is not in the spirit of the contest for a U.S. Fixed station to "run dx". Mobile- 1 point for U.S. Fixed, 5 points for Outside U.S., and 15 points for qso with another U.S. Mobile

<u>Dx stations-</u> 1 point for U.S. fixed stations, and 15 points for each qso with a U.S. mobile. <u>Mixed Category-Add</u> the qso point total as a fixed station to the qso point total as a mobile station, and multiply by the sum of multipliers worked as a fixed and mobile. Example: Fixed score: 1000 qso points and 250 multipliers. Mobile score 200 qso points and 50 multipliers. Mixed score is 1200 qso points X 300 multipliers for a total score of 360,000 contest points

# Multipliers:

U. S. Counties worked, per mode. A CW only, or Phone only station has a maximum of 3077 mults. A mixed mode station, has a maximum of 6154 mults.

### Miscellaneous:

- A. There is no digital communications in this contest. Acceptable modes are CW and Phone only.
- B. Self spotting as a fixed station is not allowed. Self spotting as a mobile is permitted.
- C. Drivers for mobile stations are permitted, provided they do not assist with in any way with the contest on air operations. This includes, but is not limited to operating, logging, spotting, and antenna changes.
- D. County Line operations: As defined by MARAC, a stationary mobile may operate from one county line, and contacts with that mobile shall count as two qso's, and 2 counties worked. Some part of the vehicle must be in both counties for the duration of the qso. The mobile may also log two qso's for contest scoring.
- E. Independent city-A station which operates from any of the independent cities, as defined in the MARAC awards rules, must choose, and use only one county for use in the contest exchange, for the duration of the contest.
- F. This contest, unless otherwise stated above, shall follow the ARRL General Rules for

Contests.

### Awards:

Plaques to be awarded to top scoring entrant in each Category, .

Certificates will be awarded to category runner up, as well as top scores from each U.S. State, Canadian Province, and DXCC Entity.

Participation certificates will be awarded to those who submit logs containing 100 qso's or more. Any one entrant may win only one contest award in any given year.

Additional awards may be available at the discretion of the Contest coordinator, or the MARAC Board of Directors.

Plaque sponsorship-If you are interested in sponsoring one or more awards, including one which is not listed, please feel free to contact the contest coordinator.

## Ran All (State) Counties Award

OBJECTIVE: To make contacts with amateur radio operators while transmitting from every county in a State.

SPECIAL RULES: The applicant must make Valid Contacts while transmitting from every county

in a State while the applicant is in a Mobile Operation or Portable Operation.

AWARD LEVELS: A separate award is available for each State. All counties in a State must be

completed for the award for that State.

Each State award may be earned multiple times up to a maximum of ten (10) times, but only the first time is a numbered award. An applicant must complete

transmitting from all counties in a State before starting over.

APPLICATION AND FEES: Standard application. Logs must indicate the State and county transmitted, the station worked, the date of each contact, and the date of the last contact. Band or Mode is required for endorsements.

There is no fee for award certificates for MARAC members. For non-members, there is no fee for the first award certificate for each State. The fee for each additional award certificate for a State is \$3 for non-members. The fee for the optional mobile plaque for each State is \$20. A trophy will be awarded for completing all States. There is no fee for the trophy.
