Dateline CW Ed, KN4Y

If CW county hunting is the best of possible worlds, what then are the others?

It is February, enough cold weather already, it is time for the hot weather, a major reason I moved to Florida. Cold weather (defined as any temperature below 70 F) should not be allowed past the Mason-Dixie line. I turn on the radio and I hear Jim running CW on the 20-meter band. I do not need the county but I can use the Stars. The rhythmical sound of Jim's CW is drowned out by the roar of Gator's 4X4 coming down the driveway, he slides to a stop at the recycled railroad tie. He gets out of the truck and makes a stop at the mail box. I open the radio shack door, "Good day, let me help you with the lattes." "A good day to you Dude, I have your mail." I look out the window and see one successful kamikaze squirrel.

I remove a latte from the container and take a gulp of the hot nectar of the Gods as I sort through my mail. I remove several large envelopes and hand them to Gator, "I think these are probably QSO party certificates. How about checking them out while I insert two raisin cinnamon bagels into the toaster." Nominations must be received by your District Director not later than March 31ST and should contain a brief list of reasons for the nomination. Your District Director will select one nominee (one for CW and one for SSB) from those received and forward that selection, with the reasons for the selection, to the Election Coordinator by no later than April 15th. Prior winners (per mode) are not eligible to receive this award a second time. Also nominations are being accepted for the position of Vice President for a 1 year term expiring 2016.

DIGITAL HAPPENINGS #30

(January 2015) By W0NAC ("Matt")

I am excited this month to announce a great trip to Hawaii being planned by Jim (N4JT), Mike (KG5UZ), and Cheryl (KJ5PQ). They will be running all 5 counties in Hawaii on multiple digital modes from mid-February until late March 2015. They plan on spending at least 2 days in each county operating on at least 3 bands. Detailed operating schedule/times have not yet been determined, but I am sure they will be published shortly. Their flight out is on Feb 18th and their flight back is on March 30th.

Their trip will be giving some of us a "once in a lifetime" opportunity to finish both the **USA – Digital** and **5 – Mode** awards for Hawaii and I expect their operations will be extremely popular! However, their popularity could also be a big problem unless stateside county hunters exercise discipline and self-control. Some detailed suggestions will be given later in this article for orderly operating techniques.


- 1) Latest Version of Fldigi 3.22.05. You should update now.
- 2) How to Tune Difficult Modes Dave (W4YDY) has recently asked the following question: "I'm having trouble decoding a couple of modes. I saw a call sign 1 time on Contestia 4/500 and on Domino22, I only copy less than 20%. Very hard to set the indicator on the right place on the waterfall. PSK, MFSK and RTTY are easy."

Sensing that other digital county hunters may have the same problem tuning some modes, I decided to answer Dave's question here for everyone's benefit.

All of the various digital modes used by county hunters vary in the tuning accuracy needed to get reliable decoding. As Dave points out, PSK and RTTY are relatively easy to tune. However, I must disagree with his example of MFSK as an easy to tune mode. In my experience, MFSK-32 is very demanding when it comes to tuning accuracy. There are no published properties for all the digital modes that rate their required tuning accuracy. Until detailed studies are done, we will just have to use techniques that help us accurately tune "cranky" modes like Contestia 4/500, Domino-22, MFSK-32, and others.

For some of you old-timers the following discussion may be covering familiar ground. If so, just skip over the boring stuff.

There are basically 3 ways to tune a digital signal. These are clicking on the waterfall, using the fine tuning arrows, and using Automatic Frequency Control (AFC). I will discuss each of these techniques in turn using the following Fldigi screen shot for illustration:



Clicking on the waterfall – For most of us, this is the most familiar tuning method. You move your mouse pointer into either the Offset scale or waterfall itself to pop up the yellow tuning bracket (T1 on the screen shot). You then center the yellow tuning bracket over the signal as accurately as you can by sliding the mouse left and right. When you get the tuning bracket centered over the desired signal, you then left click the mouse. This will force the red offset tuning indicator (shown as T2 in the screen shot) to match the last position of the yellow tuning bracket. Assuming that you have AFC turned OFF, the red offset tuning indicator will then stay in the exact spot it was when you clicked your mouse. If you do all this with enough precision, the signal will begin decoding correctly.

However, this tuning method has some problems. It requires that you make very small (and accurate) cursor movements with your mouse. Modern mice have a very high resolution which makes them very "touchy". Even though your mouse has control settings which can help decrease sensitivity, most people just accept the default mouse settings and aren't even aware that they can be changed. In addition, our manual dexterity tends to degrade as we get older. All of these factors add up to making this tuning method almost impossible to use (by itself) for those modes that require extremely accurate tuning to decode properly. For example, I have seen weak MFSK-32 signals that need to be tuned within plus or minus 2 Hz before they would decode! Tuning with just the mouse needs help when trying to tune these "touchy" signals. The following two tuning methods supplement tuning with the mouse and DO NOT replace it.

Using The Fine Tuning Arrows – Fldigi provides 4 controls and one small display to aid in fine tuning. These are labeled F,1, 2,3, and 4 on the screen shot above. The middle button (F) displays your offset (in digits) to within 1 Hz and can be read with more precision than trying to read offset directly from the offset scale. The left arrow (1) lowers the offset by 1 Hz each time it is clicked on. The right single arrow (2) acts identically to the left single arrow except that it increases the offset by 1 Hz each time it is clicked on. The right single arrow (2) acts identically to the left and double right arrows lower or increase the offset by 10 Hz each time they are clicked on. The way to use these controls is to first center the yellow tuning bracket (T1) over the desired signal and left click the mouse to roughly center the red tuning indicator over the signal. Then, while watching the digital offset indicator (F), click on the appropriate single arrow (1 or 2) to fine tune until the signal starts de-coding correctly. Personally, I find little use for the double arrow controls (3 or 4) as I can make an offset change of 10 Hz (or more) quicker using the yellow tuning bracket, but you may find them to be useful.

Again, all of the above assumes that the AFC is turned OFF. If AFC is on, it can over-ride any manual changes you might make.

Using Automatic Frequency Control (AFC) – This control is indicated by A on the screen shot above. Clicking anywhere on the button will toggle AFC ON or OFF. The tiny square at the left end of the button is the ON/OFF indicator which lights up when AFC is ON.

Also, you need to know that AFC is not available for all modes. Of those modes commonly used by county hunters THOR, DOMINO, HELL, CONTESTIA, and OLIVIA don't provide for AFC. For these modes, the AFC button is "greyed out". All other modes do provide AFC to the best of my knowledge. For all modes that have AFC available, the required signal level threshold varies from mode to mode. This means that there is a minimum signal threshold below which AFC will no longer work. Also, if the signal strength is fluctuating widely, this can cause AFC to work intermittently. In addition, AFC will only work when you are already tuned fairly closely to the desired signal. This frequency threshold is hard coded into Fldigi software for each mode.

When ON, AFC works pretty much like one might expect. After rough tuning a signal, AFC will generally do a good job of completing the initial fine tuning required and correcting for any drift present on the other person's transmitted signal. However, AFC will usually override any small manual changes you try to make with the fine tuning arrows. This makes the two tuning methods incompatible. Also, when another station (besides you) calls a mobile and you have AFC on, your receiver will automatically tune to the other calling station's signal which is not necessarily exactly matched to the mobile's frequency.

Even worse, if both the mobile and calling station(s) have AFC active, it can lead to a situation where the mobile and calling stations end up "chasing each other" up or down the waterfall. This is why I recommend that the mobile station always lock their transmit frequency using the "Lk" button (indicated by L on the screen shot above). Also, be aware that when using Fldigi, you must re-lock your transmit frequency after each mode change.

In summary, for best results decoding weak signals and you are using any of the "touchy" modes, I recommend that you turn AFC OFF, do a rough tune with the yellow tuning bracket, then use the single arrow fine tuning buttons to fine tune until (hopefully) the signal starts decoding. Also for very weak signals, you may need to turn your Squelch (Labeled Q on the screen shot above) OFF and just tolerate the 'garbage' that shows in the decode window when no signal is present.

Digital Operations – As more digital mobiles become active, we continue to experience the "growing pains" that occur with any new operation. Last month I outlined several possible solutions proposed by Dennis (N6PDB), AI (N1API), and others. These suggestions did inspire some comments as well as some new ideas by N4JT. I will repeat the original suggestion below and add Jim's comments (in **red**) plus my reply (in **Blue**) on each subject.

To Increase QSO rate/Efficiency

a) <u>Use shorter macros and CW abbreviations</u>. Specific macro file suggestions are welcome. I will act as a clearing house and publish them here. I will start with the "W0NAC-Test-Macro.mdf" file that Sharon and I use when mobile. You can download a Zipped version of the file here: <u>https://dl.dropboxusercontent.com/u/26171574/Fldigi-Macros/W0NAC-Test-Macro.zip</u> Just Unzip the file and place it in your "C:\Users\<User Name>\fldigi.files\macros" folder to check it out with Fldigi. Please send your macro files to me as Zipped files attached to an email to w0nac@comcast.net . (NO Comments)

b) <u>Turn TxID OFF</u> (covered in detail earlier). (NO Comments)

c) <u>Use higher power</u> (CAUTION: avoid overloading final amplifiers and distorted signals). (NO Comments)

d) <u>Construct macros with provision for mode start delays</u>. For example, N1API suggests the following mobile reply macro when responding to a fixed station call: "N1API 599 599 N1API". (NO Comments)

e) <u>Use some of the faster new modes</u>. For example, N4JT has been using PSK-125 lately. Unfortunately, like all things in life, there is a tradeoff to be made. In this case, every time you double the speed of a mode, you lose 3 dB in weak signal capability. Simply stated, PSK-125 is 6 dB worse than PSK-31 when comparing weak signal decoding ability. If propagation is good and all signals are strong, this is a "no brainer" decision, but if propagation is poor you could miss making a number of potential contacts by using the faster sub-modes. N4JT: "PSK125 loss in signal is acceptable to me, I have had great success with it. Also Contestia 4-500 I like its ability to read with reasonable speed." W0NAC Reply: "I understand. It's always going to be a tradeoff between efficiency (speed) and working weaker stations. Since there will always be someone who will complain either way, I believe the mobile should make the final decision and use the sub-mode they feel is best."

To Manage Multiple Mobiles

a) Locate better frequencies (14.063?, 14.064?, 14.065?) that each mobile can use as personal frequency (informally coordinated). N4JT: "I have permanently moved to 14.068. I got tired of fighting all the other digital signals above 14070." W0NAC: "You have probably started a good trend. 14.074-14075 used to be fairly clear, but with JT-65 signals at 14.0755 and up and with other digital signals migrating up from 14072-14074, our old stomping ground is getting squeezed out. Even though 14068 is perfectly legal for Data/RTTY use, "The Considerate Operator's Frequency Guide" (by ARRL) suggests RTTY/Data use frequencies of 14070-14.095. 14068 may be thought of by many as CW territory. I'm not suggesting for a minute that you change. I would keep right on with 14068 and wait for any complaints. As the "New kids on the block" we are going to have some growing pains along the way. All I'm suggesting is that there may be other good clear frequencies between 14080 and 14095. We need to keep our options open on frequency for some time ahead." N4JT's Response: "I will consider the fact that someone may complain that I am not follow the ARRL guide. Like you said, I will stay there until it becomes a problem.

One more thing, during the major CW contests, I find even the regular digital frequencies get loaded with CW signals. For me I will try not to operate during those times.

If I must operate then, maybe I will move way up the band, perhaps above 14100."

b) <u>Have a volunteer Net Control</u> (fixed station) manage the order of mobile runs and "move" digital mobiles to an alternate frequency if someone is ahead of them on the list and they can't wait. (NO Comments)

Methods for Handling "Pile-ups" and multiple "Me First" People.

a) <u>Stations who know their signal will be weak wait</u> till the end of the run to call after the strong stations have "had their go". This will help avoid unnecessary QRM at the beginning of the mobile's run. Besides, weaker stations won't be heard early on anyway!

a) <u>Take a list at the beginning of each run</u>, and then reply to each on the list in turn. Repeat as needed.

b) Take contacts by call district, i.e. 1's, 2's, etc.

c) <u>Use split operation</u> (like rare DX stations use). Fldigi supports split operation very easily, but tuning may not be fast enough to support a high QSO rate. Also, once people determine the frequency that the mobile is listening to, the pile-up may simply move to the new frequency. It would also add more complexity to the mobile's operations that are already pretty challenging. Split operation, in my mind, requires a lot more thought and testing before it is seriously considered.

N4JT has another suggestion: "One little rock and a hard place the digital operators have, is stations are calling me on far more modes than they need for 5 mode. It really slows me down. I work them because someday I may need for transmit, but I wish people would use more discretion. Some may feel they are helping me. Someday I may have to drop back from 4 modes, I rather not at this time. " W@NAC Reply: "Having been there many times myself, I fully sympathize with your dilemma. I know of no way the mobile themselves can ration the limited time they have to put out a county or county line. You have to depend on the stations calling you to ration themselves (which is going to be extremely difficult)! However, I have come to realize that the tools available out there (Logger and Logger Map) are very limited when it comes to knowing your 5 – Mode needs in near real time. Logger II will hopefully be better in reporting 5-Mode needs in greater detail, but it will be some time before Logger II is available. In the meantime, a specialized 5-Mode tool may be developed which can help with this problem."

For those of you who don't wish to wait for the new tool mentioned above, you can create and view a Logger report that will help you avoid unnecessary calls. From the Logger main menu just select "View/Edit", "Book", "5–Mode". Then select a single state (where the mobile is expected to run). Last, click the "View" button. You will get a screen similar to this (I selected California):

By scrolling through this report you can create (in advance) a simple Excel or Paper Matrix covering each county that the mobile is expected to run. Let's say that W5QP is expecting to run 4 digital modes in the California counties of Modoc, Lassen, and Plumas. Here is one example of a very simple matrix you can make by extracting data from the 5-Mode Book report above:

This matrix tells me that when W5QP is in MODOC, I don't need to work him at all for 5-Mode (but I may still need him for his Stars, Prefix, 1X2 Call, or something else). In any event, I only need to work him one time to collect any other potential "goodies".

When in LASSEN, the situation is similar to when he was in MODOC, i.e. at most, one mode is all I need to work him on. In PLUMAS, I need to work him using 3 new modes. Personally, I would try working him on the first 3 modes and if successful, I would not call him at all when he runs his last mode. However, if any of the first three mode attempts fail, I still have a try at filling in the fifth mode.

A "real world" example of this technique will probably be more complex than this simple example, but if fixed stations use this matrix technique (along with other operating practices mentioned earlier), they can really help mobile stations use their limited time more efficiently.

January Digital County Hunter Activity:

The "digital highways" slowed down a quite a bit in January. Counting just the spots posted on W6RK, there were about 43 counties (not all unique) run on various digital modes. The vast majority of these runs were made by N4JT using a variety of modes and bands. Various other non-county hunters accounted for 6 different counties (mostly using PSK). Hopefully things will pick up in February and March, especially with all the mobile digital operations planned in Hawaii.

Active County Hunter Award Status:

As can be seen in Table 3 below, many digital county hunters continue to make great progress toward completing their "**USA** – **Digital Award**" and "**5** – **Mode Award**". 14 digital county hunters have logged over 1000 counties toward completing the "**USA** – **Digital Award**". Two more are "knocking on the door" with 900 or more digital counties.

13 digital county hunters have now logged over 50% of the 15,385 mode/counties needed to complete the "**5** – **Mode Award**". These are shown in **red** in Table 3. The leader for this award is still Dennis (N6PDB) who has worked 10,133 (**65.9%**) of the 15,385 Counties/Modes needed to complete this award.

I would like to mention again the little known award under the 5 – Mode award for working all counties in a state using 5 modes. As far as I know, I am the only one so far to receive one of these WAS awards (for CO). Check your records – you may be eligible for one or more of these 5 – Mode WAS awards. Please read the MARAC rules for the 5 – Mode award for more details.


