#### Dateline CW Ed, KN4Y

Happy it is for amateurs that a higher power has laid on a few the curse of being a CW county hunter.

There is the bite of a cold nip in the air as I walk to the ten meter vertical antenna to repair the elevated radials torn off by falling pine tree limbs during hurricane Hermine. I survey the problem and there is a simple fix, refasten the fork terminals back onto the antenna radial block and refasten the rope support. It would be nice if all problems had a simple fix.

I head back to the radio shack to be sure I have changed all the clocks to Eastern Standard Time and for some reason I wonder how Gator is enjoying the Redneck Coalition for Ethanol annual conference. I think the meeting is just a bunch of bootleggers shooting the bull, but Gator calls them high-spirited motorized connoisseurs. As I approach the radio shack I hear CQ, CQ emitting from the radio speaker. I quickly go to the radio desk and it is a FIST station calling adjacent to the CW twenty-meter call frequency. I turn on the computer and think to myself I will show Gator I can post process a log just as efficient as he thinks he does. I locate the multi-color transgender memory stick and insert it gingerly into the USB port.

I click on the Writelog logging program and open the file for the Texas QSO party. That was easy. I scan the log and see I worked six mobiles and I read; Jerry, K5YAA, Guff, KS5A, Alan, N5NA, Chuck NO5W, Bob, W0BH, and the Central Texas & Contest Club, W5CT. The band conditions were terrible Sunday but overall I made 158 QSO's, worked three No-Star and Four 2 x 1 call. That was easy, I shut the computer down and go outside and start collecting and burning the fallen tree debris caused by the winds of hurricane Hermine.

Time passes and I am still collecting and burning the tree debris in a fifty-five gallon steel drum when I hear Gator's 4x4 enter the driveway and slide to a stop at the recycled railroad tie. I wave and head to the radio shack. I shout, "Welcome back to God's county, how was you trip?" Gator is carrying a white cardboard container as he slides out of the cab of his 4x4, "Good to be back, I stopped and got several cups of latte and a few éclairs, did you behave yourself while I was gone? I shake my head yes, but not by choice I murmur to myself, "I have been cleaning the mess left by hurricane Hermine. How was your trip?" Gator goes to the computer and turns it on, "I see you worked on the Texas QSO party log, did you send in the TQSL and the Cabrillo file to the Northwest Amateur Radio Society?" I look gloomy, "Damn and I was going to brag how I can do what you do with the contest logs." Gator laughs, "Someday maybe, but not in the near future." Gator sends in the two Texas QSO party files and next reads the e-mails. "Wow! Dude I see you are now a member of the CWops. That is a great accomplishment, my congratulations; I guess they have no age restriction." I give Gator a dirty smirk, "Yes Gator, Barry, K2MF, nominated me and I was approved on the first ballot." Gator is not listening he is looking intently at the computer.

He turns around in the chair, "I see you got a LC from Bob, KA9JAC, have you thanked him yet?" I shake my head from side to side, "I will put it in my thank you bucket list. Getting the LC is good news Gator; it means the MARAC awards system is functioning again, check it out." # Montana Trip – W0GXQ & K8ZZ

Last June Ed had mentioned to me that he needed to get out to Montana to fill some "transmit" needs, and that is when we decided to do a dual-op trip. Try to keep the daily mileage under 400 he said! We both agreed that the end of September would be a good time. This way I could combine the trip to coincide with my 60<sup>th</sup> High School class reunion!

He laid out his route in Street Atlas and emailed the file to me. It would be my job to draft an itinerary that would look at 400 mile days. I informed Ed that the trip would require eight days to complete. We made plans to meet in Sioux City Iowa around noon on 21 September, get the mobile set up and head out the next day. The second station would be a KX-3 powered by a Stanley J509 battery pack which ran two days easy. A fancy Roadrunner Fuse Block with five active slots, were fed from the battery pack with Anderson connectors. We also carried a small laptop computer (with backup) both loaded with our route, and the usual spare IC-7000, and antenna. Ed positioned his Kent TP-1 paddle on his "lap desk" and plugged it in line with my trusty old Bencher. After parking Ed's vehicle at my brother's QTH, we met Mike NF0N for a good Mexican dinner in Dakota County NE.

Ed's planned route was via South Dakota Interstates and return through the state of Nebraska. Well, since I had no NE needs on his route, we agreed to make the return trip back through SD, but north of I-90. Now we could both benefit!

The first day out would be 470 miles of interstate to Lawrence County SD. We used this day to refine our operating and logging procedures. Our plan was to try and work SSB in each county; Ed would run SSB and I would follow with CW, but we later determined that it was more fun to just trade the CW runs when it fit our fancy. Weather was rainy and bands so-so. I had planned to surprise Ed with a stop by the antenna farm of W0SD in McCook County, but missed the turn. Check out QRZ.com. The night was spent at the Holiday Inn in Spearfish.

The next day would be a 500 mile drive, from Spearfish SD to White Sulphur Springs MT in Meagher County. Just could not come up with a way to shorten this leg of the trip. You take the overnight stops where you can find them. Driving conditions were much improved this day, but the bands were getting worse. We stayed at the All Seasons Inn & Suites.

Day three would only be 378 miles, but our plans called for three county lines and one side trip. Our destination was Shelby MT in Toole County. We took US-89 north from White Sulphur Springs to Forest Service Road 267 and headed the three miles east to the Cascade/Judith Basin line. This rugged trail took us 35 minutes, but it was one of the most beautiful spots we had seen. With this remote location and the poor band conditions (terrible QSB!), it was difficult to make a lot of contacts. North of Great Falls we took route 225 which turned out to be 80 miles of "white knuckle driving". I learned the hard way that a dash-lined road in Montana is not blacktop! The alternative was much longer but probably would have been faster. Next time I will scan each suspect route with Google Earth. The Comfort Inn in Shelby was very nice.



We had to cover 450 miles on day four, stopping in Mineral County. This included stops at the Lincoln/Sanders and Mineral MT/Shoshone ID lines. We had a very nice visit with Bob, K7TM on the state line. This was my first trip on US-2 this far west and I found the scenery to be absolutely beautiful! The weather was perfect this day. I had a short chat with Larry W7IN when we stopped in Plains MT for a bite to eat. We stayed at the Big Sky Motel in Superior MT.

The fifth day out would be 415 miles to an overnight in Gallatin County at the One Horse Motel in West Yellowstone. Reservations were made nearly two months prior to the trip and we got the last room! Headed east on I-90 to Fish Creek Road (exit 66) and followed this forestry road to Lolo Hot Springs on US-12. I think we averaged 15mph for what seemed like hours! But the best was yet to come . . . a logging road to the Clearwater/Idaho ID county line turned out to be on top of a mountain. We could see 360 degrees of mountain ranges, and was a perfect spot for transmitting. Lots of contacts were made even though it was another day of poor band conditions. As far as road selections, "been there, done that and don't care to go back!" It was another beautiful, but long 12 hour drive! Gallatin County would have to wait until the next morning.



Day six would be 414 miles east to Gillette WY. We spent a few hours in Yellowstone National Park as neither of us had ever visited the park. Brunch at the Lodge was excellent and of course we stayed until 11am to video Old Faithful! All this resulted in a late arrival at the Holiday Inn Express.

We were off to Fort Pierre SD on day seven which would be a short 365 miles. We decided to run the C/L's of Meade/Perkins, and Ziebach/Dewey. The drive was relaxing and we arrived early at the Holiday Inn Express. We stopped at Mad Mary's in Pierre and each of us had a Walleye dinner. It had been another brilliant sunny day with mild temps.

Day eight would be 388 miles back into Woodbury Iowa (around 3pm). We missed the scenery of Montana but it was a much easier drive. Ed decided to load up his mobile and head back to Topeka, which would turn out to be a long day for him.

I'm sure the poor band conditions precluded many from making their last

county contacts. The needs list indicated a possible 68 last counties on our route; and I believe the completion rate was about 52%. I made very few contacts on the higher bands (52) during the entire trip. Ed picked up 28 new transmits and a load of band/county contacts. He now needs less than 500 to reach Ran All Counties I. Total miles 3,292 (71 counties) and 2,515 contacts (434 SSB and 2,081 CW).

On two different days in Montana we experienced no cell coverage for over six hours however, most of the band changes were spotted for us. Thanks to everyone, especially K0DEQ who hung with us most of the trip to provide assistance.
