Re: MARAC Listings for James Grandinetti


Our firm represents James Grandinetti. It is our understanding from him that you removed all of his personal and other information from the MARAC online database on or about April 17, 2017, despite the fact that he is a current MARAC member and has paid his dues through this year and beyond.

On April 18, Mr. Grandinetti emailed MARAC's president demanding all of his personal information be returned to the online database as it was before April 17. It appears that it took you until yesterday or today to replace the information in MARAC's online database.

The removal of his information was willful and intentional and appears to have been done only for his call signs. The removal of this information coincided with his opposition to current members of MARAC's administration, and the timing of your actions would support claims of intentional tortious conduct actionable against MARAC and all of you personally under Kansas and South Carolina law.

Mr. Grandinetti has asked us to pursue all available legal remedies against you if you delete, remove or misrepresent any of his information in the database again.


I am writing in my capacity as general counsel for the Mobile Amateur Radio Awards Club in response to your letter of May 10, 2017 on behalf of your client, James Grandinetti.

Your letter, and your client's earlier communication to MARAC on this subject, misstate and distort relevant facts. None of the people to whom your letter was addressed, nor anyone else involved with MARAC, removed any information willfully or intentionally. In fact, your client's information was never removed from the MARAC database.

Because of technical issues within the webserver provided by EasyCGI, it was determined that the database used to display information on the MARAC website should be changed from Microsoft Access to Oracle MySQL. This change involved only the database used to display information on the website, NOT the MARAC database which continues to be an Access database in which no information relating to your client or anyone else was eliminated. The proposal to change to MySQL for the website was approved by the MARAC board of directors. This change required the webmaster to develop and implement a manual conversion process. Some problems were encountered in this conversion which resulted in some information not transferring properly. At least 10 MARAC members (including at least one member of the board of directors) have reported that their information was not transferred correctly, thus contradicting your client's assertion that he was targeted individually. Probably many more MARAC members were affected but either did not notice or did not report the matter, realizing that the problem would be resolved in due time. Again, no information in the master MARAC database was deleted or otherwise affected.

When the problem with the online database was discovered, a message was added to the MARAC website giving notice that there were issues which were being investigated. Everyone involved with MARAC, including the webmaster, are volunteers who have their individual professional and family responsibilities. MARAC does not expect the webmaster or anyone else to put the organization's needs ahead of their family or professional obligations, and neither should your client. In this particular situation, the webmaster was out of the country for several days during the latter part of April and had unanticipated family obligations during early May. The problem with the transfer of information received his attention when he was able to devote time to this task.

All MARAC members, including your client, owe a huge debt to the webmaster, David Pyle, for the many hours he has devoted to MARAC. Threatening legal action is totally unwarranted under these circumstances and is also an unacceptable response to his unselfish service to MARAC and all of its members.

What is not good for the mobile is not good for the county hunter.

Lo-and –behold here cometh the month of June with summer and in Florida the start of the hurricane season. June is the month with the longest daylight hours of the year. It is believed that the month is named after the Roman goddess Juno, who is the wife of Jupiter and is also equivalent to the Greek goddess Hera who is thought to be the goddess of County Hunter teams. It is hot, pushing the 90's. I wonder if during June there would be county hunting if air conditioning did not yet exist. My horrible thought process is interrupted by the controlled roar of Gator's 4X4 coming off the main road and sliding to a stop at the recycled railroad tie. Suddenly I have this urge for coffee.

Gator comes into the shack carrying the white cardboard container, I start to salivate. Gator pops the top of the container "Here Dude you look like you need a hot latte to complement this heat." I take the latte, "Thanks Gator, I was getting the computer warmed up to see my results operating in the Nebraska QSO party, the 10-10 International QSO party and our mobile operation in the Florida QSO party. 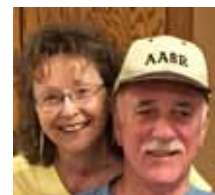
