mentioned that nobody runs on the net frequencies anymore and nobody is running a net. Can you really blame them? Who wants to sit around all day with so few mobiles running? We have some really great tools that allow mobiles to spot themselves. Most mobiles try the normal frequencies first but if they are busy they will move to a clear frequency. The days of putting your receiver on a frequency all day are over. Many of the POTA-WWFF-KFF activators who are good for counties too will run on other frequencies and most are kind enough to spot themselves so we can find them. You really should be watching the spotting apps or you will certainly miss lots of counties.

According to an article I read the other day, FT8 contacts are now 20 percent of all contact made today. FT8 has been great for the lousy band conditions. 20m is usually filled to the brim especially on the weekends and 40m and 80m are usually quite crowded in the evenings. I spend a lot of time on 160 in the evenings and have worked many familiar faces there! During the day I am usually on 30, 20 or 17 meters. If you are already using FT8 please make sure you are running the latest release version or the newest beta. The older betas do not support some of the new additions like RR73.

A number of people have expressed some concerns about stability of CQ Magazine, as they were unable to print the November or December 2017 of the magazine. I have not had any discussions with K1BV on what would happen if CQ had to close. I am sure that Ted would carry on with the awards on his

own but MARAC would be open to taking over the USA-CA award if it should ever come to that.

The Board and the Awards Committee have been working on ideas that will encourage new people to try county hunting and encourage more mobile activity with new awards. The caveat is that whatever we decide to do will have to be more automated. There have been no decisions made but some of the ideas that have been discussed have been a repeat offender award for a mobile activating a county a number of times and a late night award for activating counties between 0000z and 1200z. These awards have been pretty popular with the POTA activators and chaser/hunters. Other thoughts are to have some nice entry level awards to chase such as 100 counties, 200, 500, 1000 etc. QRZ offers their own county certificate with levels and they have issued over 8300 of their online awards. We need to figure out how to get those people into MARAC.

Another option is to change our 1st time award and remove the dependency on USA-CA and allow people to apply for 1st time using our current rules or a modified rules set for this award. Most of the more difficult and prestigious MARAC awards require USA-CA. It seems odd to me that MARAC would be limited by an award it does not control or offer. USA-CA will not be available on LOTW maybe ever and even if it were, the one time out of pocket costs of 15 cents a contact plus award fees would make the award cost over \$500.00. There is currently no bureau system to help negate some of the post costs and electronic means of confirmation other than EQSL have been dismissed such as scanned or email confirmations. So obtaining USA-CA is harder than ever. Yes we all did it and we paid our dues etc. So what! It should be obvious to most that activity is way down and MARAC as a whole is not a young group. Many very active mobiles are no longer capable of running any more and we need to find some new people to continue the tradition.

We are looking at some other solutions on how to get people their certificates such as a server based system where you upload your application, it is approved and the award is automatically generated for download. The major problem that we continue to have, is that either people with the skills to help are not interested in helping anymore or we simply don't have the skill sets to move forward with improving and upgrading our technologies. I appreciate the hard work of K4PBX, K8EMS, WQ7A, W0NAC, N5MLP and of course KD9ZP. These people are already working very hard for us. Maybe with some new blood will come people with these skills sets who can help.

AB7RW-Phil is getting the hang of thing and processed a bunch of awards recently. If you are still waiting for an award please contact Phil as a few awards have slipped through our grasp and we want to make sure that everyone gets every award they deserve.

Don't forget the Michigan Mini is coming up in April and our 50th National will be in Kansas City in October. I will not be able to attend the mini but I hope to see everyone in KC! I am always open to suggestions and comments so feel free to email or call.

Information from the Awards Secretary

The Awards Secretary, Phil, AB7RW has processed most of the backlog of awards requests received in the past month and you may continue to submit new applications from this time forward.

Quite a few awards submissions have been received that are duplicates, incomplete, or otherwise not correct. Please review your submissions carefully before clicking the "Submit" button.

If you find an error after submitting it, please send an email to: marac.awards@gmail.com and Phil will delete that entry. However, he cannot correct your submission so you will need to submit a replacement document with the correct information.

If you wish to give <u>another</u> operator a last county award for giving you a contact in a last county, please ensure you use the correct application form titled "Last Application (LC1 and LC2)" on the "Awards" tab of the MARAC website. Note:

LC-1 awards are for the last county in one particular state
LC-2 awards are for the last county in the entire USA (known as "Whole Ball of Wax" – WBOW)

The selection of either of these awards is accomplished in box 20 of the form (see screenshot below). If it is a LC-2 and you wish to give a plaque to that operator for the WBOW, be sure and select "Yes" from the dropdown for Box 21 and then enter a message you wish to have engraved on the plaque in box 22 (40-character limit).

Detailed instructions for all fields (boxes) in this form appears in an instruction sheet immediately below the form. The following is an excerpt from that instruction sheet pertaining to boxes 20-23:

	In this box: Select LC-1 if it is your 'Last In A State' Select LC-2 for the 'Last For The Whole of Wax'	
Box 21 - <u>Back</u>	When someone gives your last, most CH'ers will order a plaque for that person The Plaque (and Certificate) costs \$20 The Email notification is free The cost is the same for both MARAC members and non-members	
	When you give a LC-2 plaque to the person who gave you the 3077th County It is Customary to add you personal note on the plaque Most say: 'TNX For The Number 3077 For 2nd Time' (or whatever) However, you might say: 'TNX Frank For Going The Extra Mile' Note: 40 Characters is the Limit!	
Box 23 - Back	If you want to sent a note to the Awards Manager - do it here Note: 50 Characters is the Limit!
