Election Tidbits

Voting on the By Law changes is now complete. More information on this in K0DEQ's article elsewhere in the newsletter.

Voting for CHOTY – SSB is final. Normally the annual awards are announced at the Convention and since there is no convention this year, the board will decide when to announce the winners. The CHOTY – CW will be announced at the same time.

While on the subject of Annual Awards - 4th quarter voting will be open July 3rd thru July 17, 2019. This voting period covers the time frame of *April 1 thru June 30, 2019*. All MARAC members will receive an email from Simply Voting with instructions. When you have finished voting, click on **CONTINUE** and **CONFIRM** to complete the voting process.

Simply Voting is automatically set up to send two (2) reminders during the voting period. If you voted and receive a reminder email, it means you did NOT click on CONTINUE and CONFIRM. Please follow the instructions in the email and go thru the process again to cast your ballot. The second reminder is set up for the day before voting closes for those who are procrastinators or just like waiting. There are safety features in place to keep you from voting more than once. If you have any questions or problems, please email me and together we'll get the issue resolved.

You will be voting for 1st and 2nd place for the following awards. Please check each entry for accuracy before submitting.

CW & SSB Mobile of the Year Team of the Year CW & SSB Net Control of the Year

When voting for Net Control of the Year, remember to take into consideration nets are no longer occupied by a Net Control. You will be voting for the individual(s) who assist the mobile by spotting and sticking around to help with relays.

If you are a NEW member or are REJOINING MARAC after a lapse in membership, you will NOT be eligible to submit nominations or vote in an election until the first day of the month following receipt of your dues and valid membership application by the Secretary of MARAC.

Those individuals who have maintained uninterrupted membership status are not restricted from nominating or voting in the upcoming election.

If you are unsure of your membership status, please visit the MARAC website, click on **COUNTY HUNTER DB**, enter your call in the **Call Lookup** to determine your MARAC Expiration Date.
