County Hunter of the Year - 2023 By Ron, N5MLP

Nominations for County Hunter of the Year – SSB and CW Are Open As of 2/1/2023

It is time to begin the process of determining who the County Hunter of the Year is for both SSB and CW operation. This year the nomination process will be different than it was in previous years due to a significant change approved by the Board of Directors on January 23, 2023. A copy of the entire updated rule appears below for easy reference and it will be published in an update to the rules effective 1/23/2023 which should be posted on the website by February 1, 2023.

Important Dates Associated with the 2023 CHOTY Process:

- 2/1/2023 Nomination period begins for both SSB and CW
- 2/1/2022 through 1/31/2023 12 month period of activity associated with nominations for 2023
- 3/15/2023 Nomination period ends at 11:59pm Pacific Daylight Time. (Nominations must be received by the Awards Manager by that time).
- 3/16 through 4/19/23 Awards Committee reviews nominations and determines up to three individuals who will appear as nominees for each category (SSB and CW) on the electronic ballot.
- 4/20/2023 Awards Manager forwards the list of nominees for each category along with supporting documentation (nomination justification and biographical information) to the Election Coordinator for publication in the May, 2023 issue of the RoadRunner.
- 5/1/2023 Nominee list and documentation appears in the May RoadRunner
- June 2023 Election Coordinator conducts election via electronic voting service to determine winners.
- July 2023 Winners announced during the Annual MARAC meeting

Revised Award Rule for CHOTY Was Approved by the Board on January 23rd

The revised rule changes the process where all nominations will be forwarded by the original nominator to the Awards Manager instead of one of the District Directors. There will be no limit on how many nominees in any particular category can be submitted from any specific district. The Awards Committee will review the nominations and decide which nominees will appear on an electronic ballot as described in the rule in accordance with dates specified above.

The complete revised rule for this award appears below:

County Hunter of the Year Award – SSB

IN MEMORIAM:	The County Hunter of the Year Award - CW is in honor of Ed Sanders (WA6VJP, SK). Ed was a seven-time winner of the Net Control of the Year Award – CW, as well as a winner of the County Hunter of the Year Award - CW. Ed had one of the best "fists" in America and worked all counties on CW five times.				
OBJECTIVE:	To recognize members of MARAC who have made a significant overall contribution to MARAC and county hunting during the 12 months immediately prior to start of nominations for this award.				
SPECIAL RULES:	 The recipients of this award are determined by an annual ballot of the MARAC membership. The vote is conducted before each annual meeting. The nomination process for thi award changed in January, 2023 and is described below: NOMINEES: Nominees for this award must be active members of MARAC in good standing and whose membership has not expired at the time of nomination of at the time the voting ballot is prepared for distribution. A noted in criteria 3h below, the nominees for a particular category (SSB or CW) for this award cannot have been a winner in the prior two years in the same category. NOMINATORS: The candidates for the award are nominated by any active MARAC Member in good

New Awards Feature on Website By Don, K3IMC

Examine the status of your recent Last County Applications

For reasons I have never figured out, our web server is erratic in sending out confirmations that you have submitted an application for a last county award. It is likely that you no longer receive an email indicating that you submitted an application. With no other way to determine if your request was accepted and is awaiting processing, some county hunters submit a second application.

To help provide feedback to you to see if your request is there as well as the status of your recent requests, I have added a new feature to check the status of all your applications submitted over the last 90 days.

This feature can be found on the MARAC webpage by clicking on the "Awards" button in the main menu. A new sub menu list of buttons will appear. The first row of buttons will contain the buttons used to submit applications online. Immediately to the right of these buttons is a new button labeled "Check Submitted Application". Clicking this button will present a new display allowing you to review the status of recent Last County Applications you have submitted to mobile county hunters. You can also review Last County Application that have been submitted to you while you were mobile. To use this feature, enter you call and click the desired option button.

In the future, you will be able to review your submitted Worked All County and Ran All State Application. At the moment however, these features are still under construction and are unavailable.

Awards Committee Report By Ron, N5MLP

New Rules and a Rule Change Approved by BOD on 1/23/2023

The following two new rules were approved by the Board of Directors at a special board meeting on January 23, 2023. They have been added to the "General Rules and Definitions for MARAC Awards" section of the Award Rules document:

Robotic or Unattended Operation

All contacts for MARAC awards require that the operator be physically involved in each and every contact, without the aid of software that would otherwise make the contacts without the presence of the operator.

Self-credit

Self-credit is the ability for a mobile/portable operator to claim credit for their own needs in a county (stars, prefix (if applicable), Bingo Cinco credits, bands, etc.) which they transmit from as a reward for having made the effort to travel to that county and make contacts available to other operators. They must make at least one valid HF contact with another operator to claim any credits they have for themselves and for some awards both operators involved in the contact must have certain qualifying credentials (e.g., be a Bingo award holder, be a Master Gold award holder, etc.) for both operators to claim self-credit.

The capability to claim self-credit on 14 specific awards was added after the rules had been in place for those awards beginning in 2017. The MARAC Board of Directors meeting minutes for a meeting held on February 15, 2017 are published in the March, 2017 RoadRunner issue (available on the MARAC website). The following paragraph refers to the decision to make those changes:

"The changes will allow a mobile or portable station who transmits from a county to be able to obtain credit for his/her own needs in that county and thereby act as an incentive to licensed radio amateurs who are working toward various MARAC awards to go mobile/portable and put out more counties. Exact wording changes were provided by the Awards Committee. After considerable favorable discussion on this matter, the Board of Directors voted unanimously to approve the changes as written. Vote was unanimous."

<u>Use of self-credit features is optional.</u> Some operators do not wish to use self-credit and are not required to implement that option. Logger 2 provides settings options where each user can specify whether or not they wish to use self-credit features of two different groups of awards. One group is the Bingo, Master Gold, Master Platinum, Mobile Diamond, and Double Diamond awards while the other group is a list of awards approved for self-credit since 2017.

All MARAC Awards that allow for credit or self-credit for transmission from a county require that the operator be physically located in that county.

Awards that have contained self-credit capability since their inception include:

- Master Gold Award
- Master Platinum Award
- Mobile Diamond Award
- Double Diamond Award

Note: The requirements to be able to claim self-credit for the above awards typically requires both operators involved in a contact to have certain credentials before self-credit can be claimed. Just making a contact with another operator does not qualify for self-credit unless those specific additional requirements are met. See each award's description for details on requirements.

Awards that self-credit options were added to after their inception (in 2017 or later) include:

- 1. Worked All USA Counties Award (2nd time to Nth time)
- 2. USA-CW Award
- 3. USA-SSB Award
